How many you have shortlisted and how many you have interviewed in this recruitment round. May I also seek a copy of the ad went out to public and the appointment letter sent to the appointee, feel free to redact any personal information."

Please see below my response to your request.

Public nominations for the New Zealand Standards Approval Board Member position were as follows:

- Te Puni Kokiri, Ministry for Women, Ministry for Ethnic Communities, Ministry for Pacific Peoples and Ministry for Disabled People
- Letters were also sent to Caucus colleagues and coalition partners
- The position was advertised on Jobs.govt.nz, Seek.co.nz, and MBIE website

Eighteen applications were received. Four candidates were shortlisted and interviewed.

MBIE provided the nominating agencies with a link to the application, and they circulated it through their networks. Data of where applicants heard about the role was not acquired.
