## Official Information Act (OIA) request for costs for RBNZ economics research conference speakers

The Reserve Bank of New Zealand is organising a research conference "35 years of flexible inflation targeting - challenges and opportunities" to be held in March 2025, with the stated aim of understanding the challenges to flexible inflation targeting.

## Background

The RBNZ's research conference is one of the premier conferences for applied macroeconomics in the Australasian region. Due to the COVID-19 pandemic the conference has not been held since 2018.

The research papers for this conference are targeted at central bank researchers and an academic audience involved in macroeconomics and banking. The RBNZ research conference has supported the transfer of technical know-how from international experts to our staff. This improves the technical depth of staff analysis and lifts the quality of the policy advice delivered to the Monetary Policy Committee.

The RBNZ will publish the research papers on our website following the conference.

## Response

No costs have yet been incurred for the conference speakers, Dr Ben Bernanke and Dr Catherine Mann. Neither speaker will be paid a speaker's fee, however the RBNZ does intend to meet the following costs for each speaker:

- Return business class travel between UK and New Zealand (approximately \$15,000).
- Accommodation during conference.
- Two dinners.
- Catering costs associated with attendance at workshop.

Aside from estimated flight costs, other costs are yet to be paid and are subject to change.
