Dear Mr Stoneley,

I refer to your Official Information Act 1982 request of 29th September 2015 relating to the response provided by New Zealand Police to a previous information request.

As part of that previous response to a request for information on body-worn cameras, New Zealand Police declined to supply information that had been obtained from public information sources, pursuant to section 18(d) of the Act. The response, however, did not list the information obtained from public sources that had not been supplied.

In your most recent request, you have asked for an index of those documents.
