REQUEST UNDER THE OFFICIAL INFORMATION ACT 1982

Thank you for your email dated 26 October 2024, seeking the following information under the Official Information Act 1982 (OIA):

May I kindly ask what is the appointment or call for nomination process for Crown Solicitor? How many applicants you have received, how many shortlisted and interviewed. What background check you have conduct before appointment and may I kindly request to view the appointment letter sent to the appointee if there is one and I am happy for you to remove any personal information. Also, can you please provide the name of all your current Crown Solicitor and their term of appointment.

The decision to appoint a Crown Solicitor is made by the Governor-General on the recommendation of the Attorney-General.

Any information relating to the appointment of the Crown Solicitor in Whanganui held by me is in my capacity as Attorney-General. The Ombudsman has previously held that information related to the Attorney-General's role as Law Officer is not "official information" within the meaning of the OIA.¹ Your request is therefore formally refused on the basis the OIA does not apply to the information sought.

However, and without prejudice to the above, I have decided it is in the public interest to provide you with the below information.

Crown Solicitor appointments

Crown Solicitor appointments are managed by the Crown Law Office and generally involve the following stages.

See, for example, Case Note W44280 of the Office of the Ombudsman

- a) The application stage: By way of advertisement,² the Solicitor-General invites expressions of interest from suitably qualified law practitioners who are interested in applying for appointment as Crown Solicitor in the particular district (e.g. Whanganui). Those who express interest are provided with relevant information packs for consideration before submitting formal applications. During this stage, those interested in applying are encouraged to seek clarification and ask questions about the appointment process and criteria, as required.
- b) The short-listing stage: The number of applicants to be shortlisted is not predetermined but is instead decided by reference to the number and quality of applications received. Applicants are advised if their proposal is to progress to the next stage.
- The evaluation stage: The evaluation stage involves interviewing the applicant(s); meeting with partners proposing to support the warrant holder; obtaining feedback from members of the judiciary, representatives of the New Zealand Police and other stakeholders; and an assessment of application documents and applicant interviews by an evaluation panel (chaired by the Deputy Solicitor-General (Criminal)) considering the evaluation criteria.
- The formal appointment stage: Along with a full report on the appointment process, Crown Law provides me with a recommendation for appointment. The successful applicant is appointed on my recommendation, as Attorney-General, and by warrant of the Governor-General. The formal appointment process involves completion of appointment documentation. The successful applicant is notified once that process is complete.
