Thank you for your email of 27 November 2024 to the Ministry of Business, Innovation and Employment (MBIE) requesting, under the Official Information Act 1982 (the Act), the following information:

- 1. Has MBIE received any requests for additional assistance, including financial assistance, of any kind from Pure Turoa from 1 May 2024 to today?
- 2. If yes to 1, please provide the details.
- 3. Please provide all email correspondence between MBIE and Pure Turoa Ltd directors or representatives from 1 November 2024 to today.

On 15 January 2025, MBIE advised you that it was extending the time available to make a decision on your request. The reason for the extension was that consultations necessary to make a decision on your request were such that a proper response could not reasonably be made within the original time limit. MBIE informed you that a decision would be sent to you no later than 27 January 2025.

On 11 March 2024, Cabinet agreed to provide \$3.05 million in support to Pure Turoa Limited (PTL) to purchase Ruapehu Alpine Lifts Limited's (in Liquation and Receivership) (RAL) Tūroa ski assets from the RAL Receivers (Calibre Partners). On 12 April 2024, the sale of RAL's Tūroa ski field business to PTL was completed. No additional assistance has been requested beyond the parameters of this agreement.
