

9(2)a had put fireplace ashes in plastic bin on top of two wheely bins on a deck containing significant fire loading on the deck. The fire on the deck was fully involved on arrival and had gone into roof cavity which contained 3 upstairs bedrooms, bathroom and significant attic space. The house had a high loading of possessions all through the house. This was difficult to completely extinguish as the fire got under the roof capping which was unsafe to safety assess easily.
