### **Request under the Official Information Act 1982**

I refer to your email dated 6 December 2024 sent to the Minister for Tertiary Education and Skills, Hon Penny Simmonds, requesting information in relation to a previous OIA request you made to Whitireia and WelTec | Te Pūkenga New Zealand Institute of Skills and Technology (Te Pūkenga) - reference TP240140.

The Office of Hon Penny Simmonds transferred your request to Te Pūkenga on 12 December 2024.

You requested the following information (we have numbered your queries for ease of reference):

- 1. A copy of the “Whitireia WelTec Te Pūkenga Paramedic Suite Alignment Project Report” (the “Paramedic Review Report”), finalized in July 2024.*
- 2. All correspondence (emails, letters, meeting minutes, and related documentation) held by your office and associated agencies under your remit that relate to this OIA request, including any communications regarding decisions to delay release of the requested information.*
- 3. Details of any actions you intend to take, or have taken, to address what appears to be an improper use of the Official Information Act by Te Pūkenga or its subsidiaries, including any plans to ensure future compliance and accountability.*

This letter provides a formal decision on your request under the Official Information Act 1982 (OIA).

### **The decision**

#### Question One

A copy of the following two Reports was released to you on 22 January 2025 in response to your OIA request dated 12 November 2024, reference TP240140.

- *Whitireia WelTec Te Pūkenga Paramedic Suite Alignment Project Report - dated 18 July 2024.*

- *Whitireia WelTec Te Pūkenga Paramedic Suite Alignment Project Report - Executive Summary*  
- dated 23 July 2024

As this Report and its Executive Summary have already been provided to you via the FYI website, we are refusing this request for the Report under section 18(d) of the OIA as it is publicly available.

### Question Two

While we note you originally asked this question of the Minister, we answer on behalf of Te Pūkenga.

In order to collate information within scope of this request we searched for emails with the following parameters to and from kaimahi (staff) involved in your request:

- Requester = Rodney Parsons
- Date range = 12 November – 6 December (inclusive)
- References included but not limited to:
  - TP240125
  - TP240140
  - Paramedic Project report.

We have located 50 emails and their attachments that fall within scope of your request, copies of which are attached at **Appendix One**.

We note there is quite an amount of duplication within the documents due to the repeat of some individual emails within resulting email threads; for completeness we have not removed duplicates.

With reference to question one above, we have not provided attachments to seven emails where the attachment is the Report (five occurrences) or the Executive Summary (two instances), as a redacted version of both documents has already been provided to you.

Certain information has been withheld from the emails under the following sections of the OIA:

- 9(2)(a) *to protect the privacy of natural persons.*
- 9(2)(ba)(i) *to protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied.*

We do not believe the need to withhold this information under section 9 of the OIA is outweighed by the public interest in its release at this time.

### Question Three

While we note you originally asked this question of the Minister, we answer on behalf of Te Pūkenga.

There has been no improper use of the OIA, nor issues with compliance and accountability, regarding your OIA request and our response. Consequently, there are no actions being taken by Te Pūkenga, nor that intend to be taken, nor that require to be taken, in relation to your OIA request.

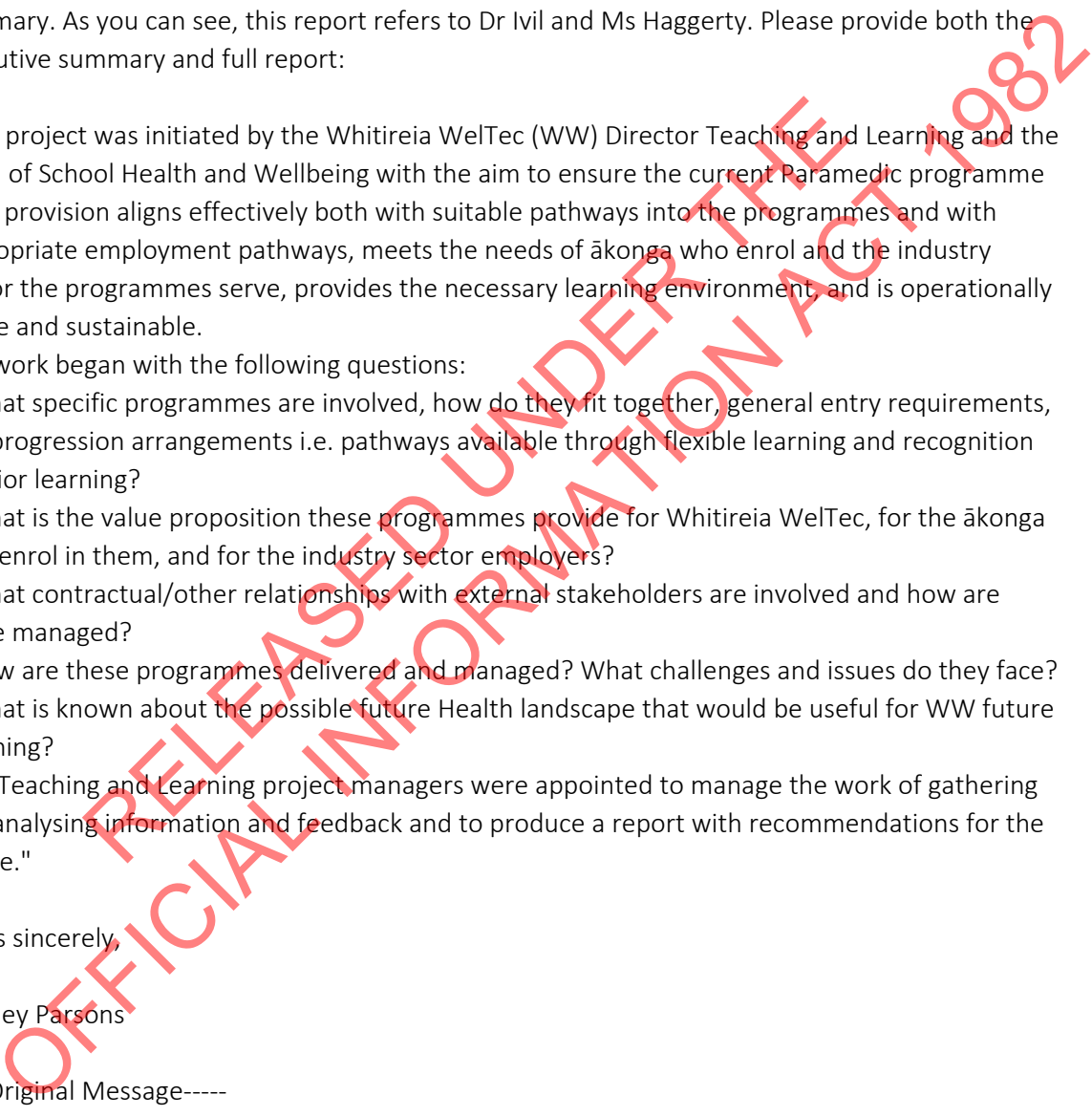

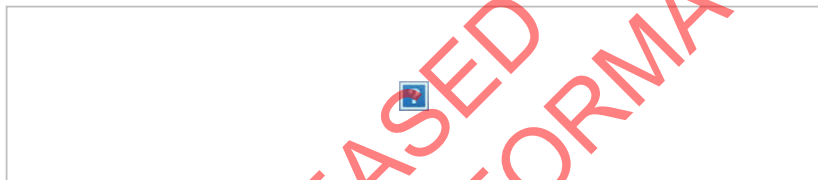

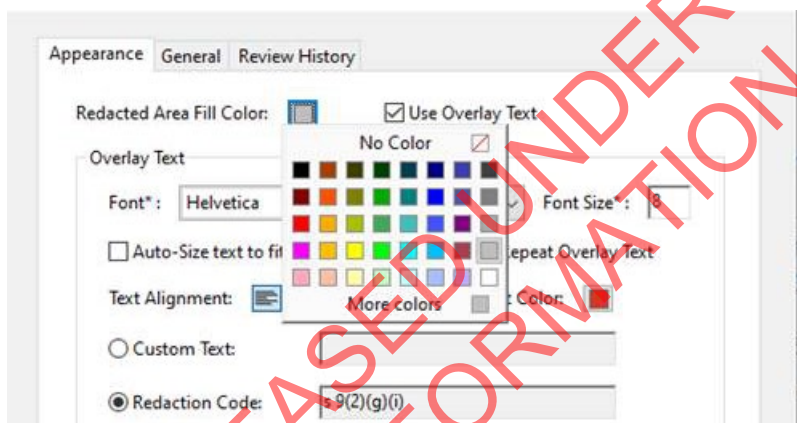

The reasons we often rely on to withhold information are under section 9 (although we do use others as appropriate).

The often-used sections are listed under section 9:

## 9 Other reasons for withholding official information

- (1) Where this section applies, good reason for withholding official information exists, for the purpose of section 5, unless, in the circumstances of the particular case, the withholding of that information is outweighed by other considerations which render it desirable, in the public interest, to make that information available.
- (2) Subject to sections 6, 7, 10, and 18, this section applies if, and only if, the withholding of the information is necessary to—
  - (a) protect the privacy of natural persons, including that of deceased natural persons; or
  - (b) protect information where the making available of the information—
    - (i) would disclose a trade secret; or
    - (ii) would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information; or
  - (ba) protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information—
    - (i) would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied; or
    - (ii) would be likely otherwise to damage the public interest;
  - (c) avoid prejudice to measures protecting the health or safety of members of the public; or
  - (d) avoid prejudice to the substantial economic interests of New Zealand; or
  - (e) avoid prejudice to measures that prevent or mitigate material loss to members of the public; or
  - (f) maintain the constitutional conventions for the time being which protect—
    - (i) the confidentiality of communications by or with the Sovereign or her representative;
    - (ii) collective and individual ministerial responsibility;
    - (iii) the political neutrality of officials;
    - (iv) the confidentiality of advice tendered by Ministers of the Crown and officials; or
  - (g) maintain the effective conduct of public affairs through—
    - (i) the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty; or

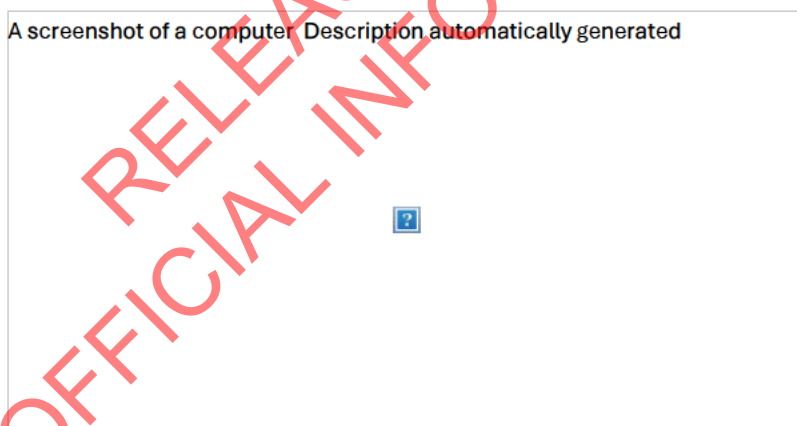

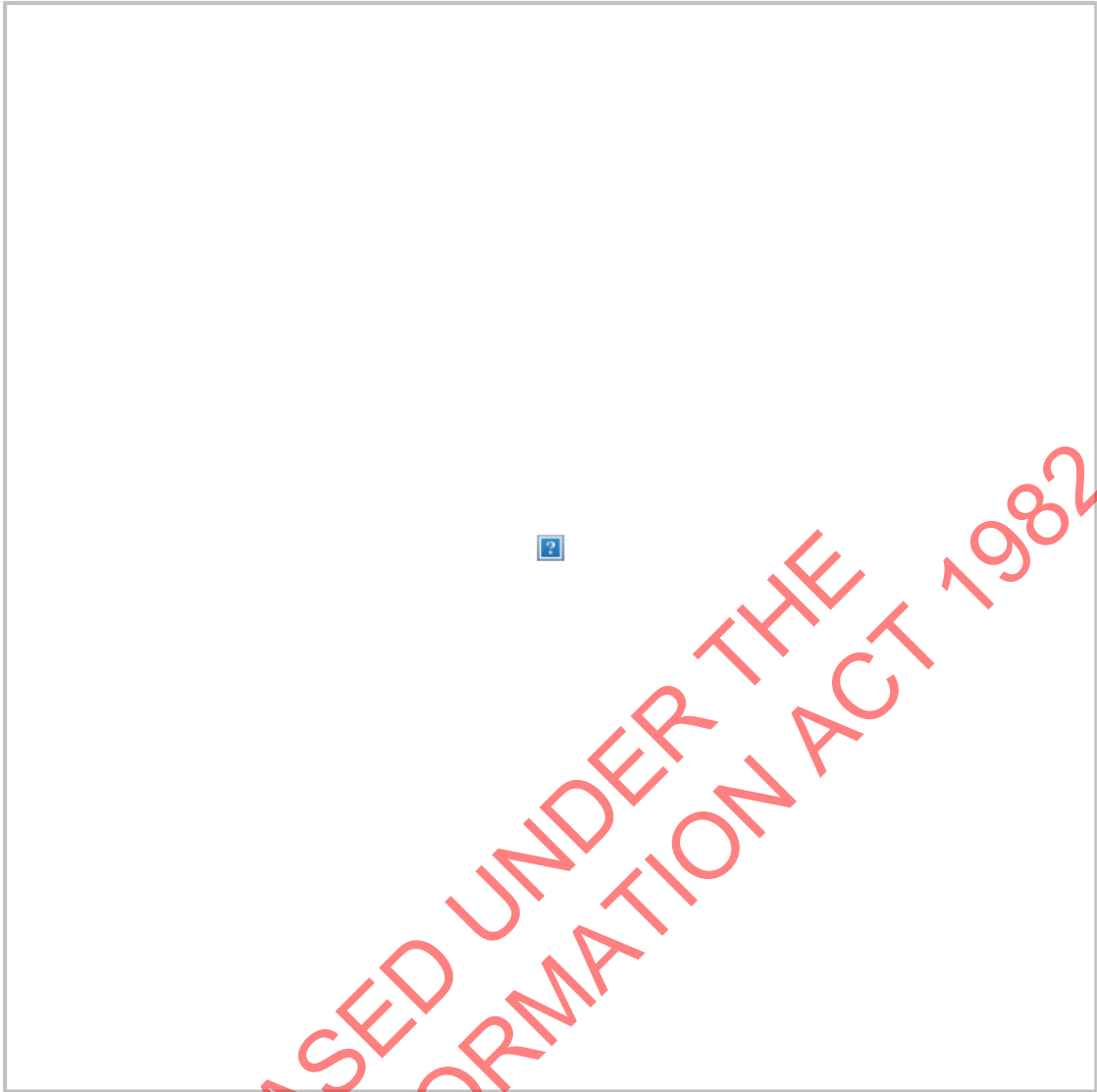

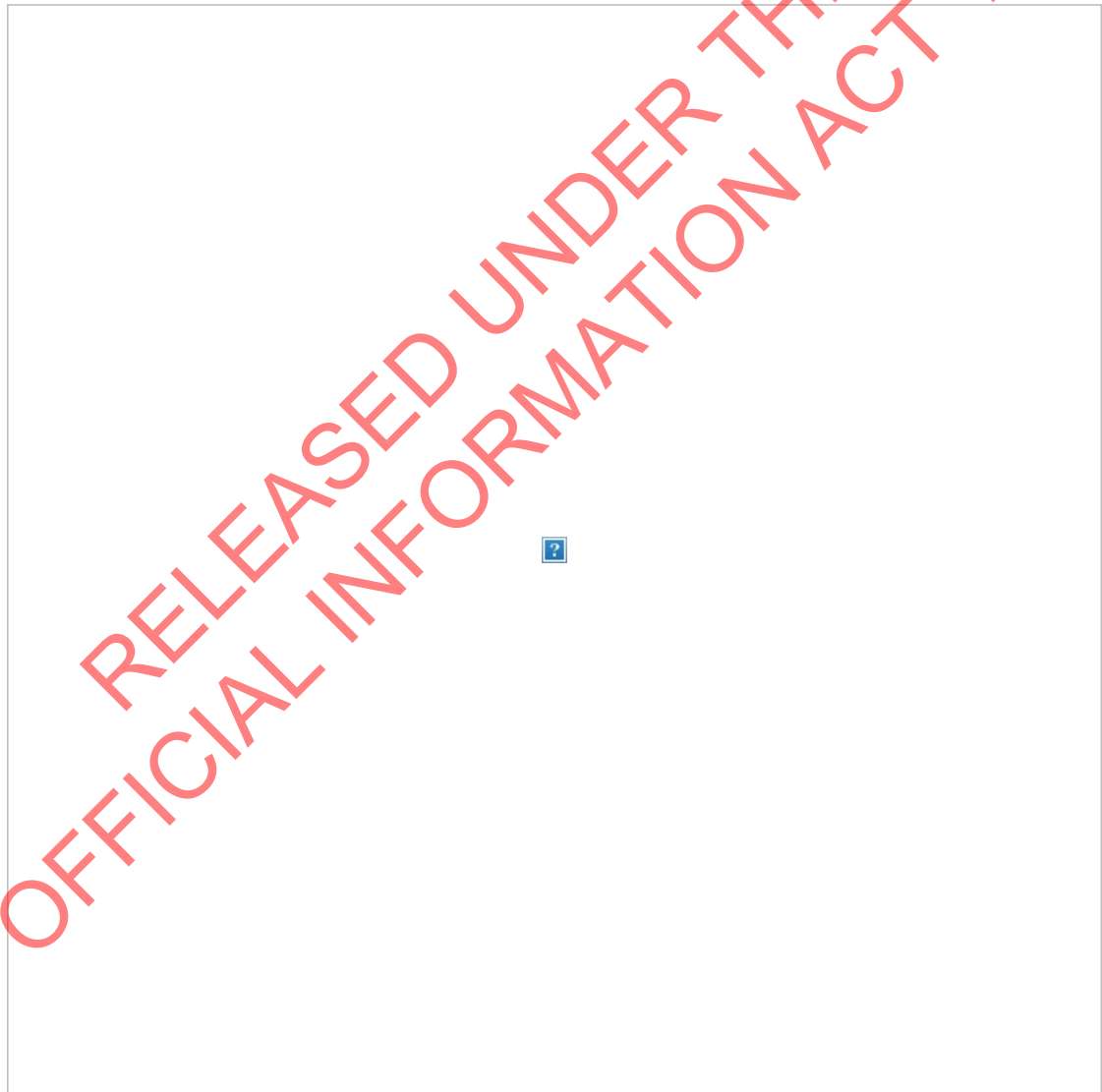

- While we consider it likely we will release the report and es, with appropriate redactions applied, we do not wish to pre-empt any feedback that may not support such a decision.

Therefore, we are not comfortable providing a decision letter to the requester until after such time as consultations have been completed.

- We also consider it likely appropriate to provide relevant ākonga and kaimahi with a copy of the report prior to its release and publication via the FYI website.

### **Extension**

- Taking into consideration all of the points above and to allow enough time for them to be actioned, the proposed extension is for 15 working days.
- We note that the extension period is close to the Christmas shutdown period for working days within the OIA, but also likely shutdown of agencies we need to consult with that may involve specific kaimahi at each agency.
- We consider the best option is to extend for a longer period of time and provide our response early if we can, than extend for too short a period and not have enough time for completion of all necessary consultations.
- Due to the Christmas OIA shutdown period, the extension will take us to a final due date of **Wednesday 22 January 2025**.
- We will do our best to get it finalised before this time and before Christmas if we can, and have stated this within the letter.

### **Additional notes**

- This requester is not happy this request is being considered as a new OIA request, rather than a clarification of his previous request TP240125.
- We offer contact with <sup>s 9(2)(a)</sup> within the letter in the first instance if he wishes to discuss the extension.
- As is his right, the requester may choose to make a complaint to the Ombudsman about our decisions, which we will address and respond to as required.
- We will need to extend the second request received (from a different requester) for a copy of the es and full report also. This will be actioned separately.

"This project was initiated by the Whitireia WelTec (WW) Director Teaching and Learning and the Head of School Health and Wellbeing with the aim to ensure the current Paramedic programme suite provision aligns effectively both with suitable pathways into the programmes and with appropriate employment pathways, meets the needs of ākongā who enrol and the industry sector the programmes serve, provides the necessary learning environment, and is operationally viable and sustainable.

The work began with the following questions:

- What specific programmes are involved, how do they fit together, general entry requirements, any progression arrangements i.e. pathways available through flexible learning and recognition of prior learning?
- What is the value proposition these programmes provide for Whitireia WelTec, for the ākongā who enrol in them, and for the industry sector employers?
- What contractual/other relationships with external stakeholders are involved and how are these managed?
- How are these programmes delivered and managed? What challenges and issues do they face?
