# East West Connections option ticks all the boxes – AA

The AA says that the preferred option identified by NZTA and Auckland Transport for the East West Connections project – which will improve connectivity into, out of and through the Onehunga-Penrose industrial hub – is the best result for the network.

The preferred option involves a full connection on the north side of the Mangere Inlet, linking SH1 and SH20 with a limited access state highway, plus improved public transport connections between Mangere, Otahuhu and Sylvia Park.

AA spokesman Barney Irvine said the preferred option included all the elements the AA and other stakeholder groups had been hoping to see.

"This option ticks all the boxes," said Mr Irvine. "It creates a seamless connection between the two

state highways, responds to the needs of freight, general traffic and public transport, and offers community and environmental benefits."

Mr Irvine added that it was pleasing to see NZTA and Auckland Transport opting for a comprehensive solution.

"They're looking to do it once and do it right, and that's when you get the most gains in terms of congestion relief, productivity, and resilience," said Mr Irvine. "This approach recognises not just the economic importance of Onehunga and Penrose, but also the need to improve connections for motorists between Auckland's east and south, including the Airport."

NZTA and Auckland Transport are now seeking public feedback on the preferred option, and are planning a series of open days this month to provide more information.

# Have Your Say on the Preferred Approach for East West Connections

Community feedback is being sought on the preferred approach identified by the NZ Transport Agency and Auckland Transport for the East West Connections project to improve freight connections into and out of the Onehunga-Penrose industrial hub as well as the reliability of bus services between Mangere, Ōtāhuhu and Sylvia Park.

East West Connections (along with AMETI) was identified in the Auckland Plan as one of the top three transport priorities for Auckland. The investigations into this project also forms part of the Auckland Accelerated Projects capital funding package included in the 2014 budget and is a key priority for central government.

For Onehunga-Penrose a staged full connection on the north side of the Mangere Inlet between SH1 to SH20 has been identified as the best long-term solution to the current transport issues.

The Onehunga-Penrose industrial hub is a significant economic area for Auckland and New Zealand, contributing \$5 billion a year in GDP and employing more than 64,000 people. Many of New Zealand's largest distribution and logistics facilities are located there because access to both state highways and connections to the rail network create efficiencies in freight movements for Auckland and the Upper North Island. This area currently suffers from significant congestion, especially at the approaches to SH20 and SH1, which hinders freight movements and ultimately restricts productivity and economic growth.

Brett Gliddon, the Transport Agency's Highway Manager for Auckland and Northland, says the preferred approach for Onehunga-Penrose will improve the reliability of freight journeys in the area and will provide an additional route which makes the transport network more resilient for all users. It will also improve pedestrian and cycling facilities and connections for buses and general traffic. In addition to the transport improvements, there are opportunities to achieve some positive environmental outcomes, particularly for the Mangere Inlet.

"This project is all about improving access into and out of Onehunga-Penrose. For this reason the new connection is expected to be a "limited access" state highway, not a motorway" stressed Mr Gliddon.

"We are still in the early stages of the project and we would like feedback from the community to help us further develop the project. We encourage people to let us know what they think" says Mr Gliddon.

As well as the approach for Onehunga-Penrose there has been substantial work undertaken to identify how to speed up bus services between Mangere, Ōtāhuhu and Sylvia Park and improve connections. These improvements are aimed at supporting Auckland Transport's Frequent Network, which will have buses and trains at least every 15 minutes from 7am to 7pm, seven days a week.

Auckland Transport's Key Strategic Initiatives Project Director, Theunis Van Schalkwyk, says that the plans propose bus priority and transit lanes at key pinch points along the future Frequent Network bus route.

"Buses often get stuck in traffic, for example along Massey and Walmsley roads. The average travel time between Māngere and Ōtāhuhu at 8am is 22 minutes, but congestion and queuing can slow this down to half an hour. Similarly the bus journey between Ōtāhuhu and Sylvia Park can take anywhere between 17 and 29 minutes.

"Bus and transit lanes would speed up bus journeys and, most importantly, make sure passengers can rely on the travel time. We are also proposing sheltered bus stops along the route, upgraded bus stops at Ōtāhuhu town centre and an upgraded bus station at Māngere town centre."

New facilities are also proposed along the route between Mangere, Ōtāhuhu and Sylvia Park to improve cycle and pedestrian safety.

The Transport Agency and Auckland Transport are planning a series of open days this month. They are encouraging people to come along to find out more about the projects, ask any questions you may have, and provide feedback on the preferred approaches.

Community feedback for next stage of East West Connections

Community feedback is being sought on options identified by the NZ Transport Agency and Auckland Transport to improve transport connections in the Onehunga - Penrose area and reliability of bus services between Māngere, Ōtāhuhu and Sylvia Park.

The Transport Agency's spokesperson Brett Gliddon says the planned improvements are important to deliver a transport network that can continue to support the growing movement of people and goods.

"The East West Connections area is the engine room of New Zealand's industrial and manufacturing economy and home to a number of our most vibrant communities. These improvements are needed to ensure that both the nation's supply chains and the local transport network function effectively."

"Public feedback to date has supported the need to address congestion and delays in the Onehunga-Penrose area, as well as improving bus services.

"No decision has been made about any of the options, and our first priority is to get feedback from the community before the project is developed further," says Mr Gliddon.

The proposed options identify roading improvements and new cycle links on the north side of the Mangere inlet, along with some bus priority lanes between Mangere, Ōtāhuhu and Sylvia Park.

Auckland Transport's Key Strategic Initiatives Project Director, Theunis Van Schalkwyk, says creating bus priority between Māngere, Ōtāhuhu and Sylvia Park will make bus journeys faster and more reliable.

"This is a key part of delivering a Frequent Network for public transport in the area and creates a better connection for people getting to work," he says.

The options being considered for the Onehunga - Penrose area range from upgrading existing routes, through to new connections between the Southwestern and Southern Motorways (State Highways 20 and 1). Common to all options is the improvement of public transport between Māngere, Ōtāhuhu and Sylvia Park as well as improvements to walking and cycling facilities, including the Waikaraka cycleway.

To help explain the options and get people's feedback, the Transport Agency and Auckland Transport are planning a series of community open days this month which will be supported by workshops on specific topics.

"We had great feedback from the community in July and August and we want this to continue with the options now being proposed. We will be using the next round of feedback to further develop and investigate the options in order to assist us in identifying the best option to progress to detailed design," Mr Gliddon says.

Open days will be held at the following locations:

- · Saturday 11 October: Onehunga Primary School Hall, 122 Arthur Street, Onehunga (10am-1pm)
- · Thursday 16 October: Otahuhu College Sports Pavilion, 53 Mangere Road, Ōtāhuhu (opposite Otahuhu College) (3:30pm -7:30pm)
- · Sunday 19 October: Te Papapa Squash Club, Fergusson Park, Olea Road, Onehunga (1pm 4pm)





Hi Tony,

As we haven't managed to arrange an alternate time for this week, I thought it would be good to at least get some notes to you that you can use for your upcoming update to the Forum. In particular, this is in response to your email below and the question for clarification on project status and milestones.

Our first key step is for the Agency and AT to appoint a single professional services team to help progress the more detailed investigation into our preferred response for the access issues in the Onehunga-Penrose area. We are nearing completion of our procurement phase and expect to officially commission the preferred supplier by 07 July. On this basis, project inception will be immediately following 07 July.

The consultant team is tasked with developing the preferred response mentioned above to a level of detail such that the Agency can report back to the Ministry by end of this calendar year (2014) on the preferred scope and associated cost. In short, we envision option development and shortlisting to occur between July and September, with further narrowing of the shortlist down to a preferred option to occur between September and November. The preferred option will need to go through internal AT/NZTA approvals before reporting to the Ministry, but as stated above, the deadline for reporting to Ministry is December 2014. This will be the starting point for discussions between NZTA, MOT and Treasury on the appropriate funding mechanisms to deliver the preferred response. This is expected to occur between January and May 2015

Detailed design, consenting, and route protection are not expected to start until July 2015 at the earliest as these phases are subject to the funding discussion that will take place in early 2015. While these discussions are taking place, AT and NZTA will finalise the Detailed Business Case (Jan to May 2015) and prepare the necessary documentation to start the procurement process for the next stages of the project. Until we know what the preferred response looks like, it's going to be hard to nail down a construction start/end date, but we are still collectively committed to trying to achieve completion by 2021, as stated in the Auckland Plan.

It is our intention to continue working with the Forum as we move through the project development process. As you can appreciate from the above, we will be moving quite quickly once we get started and that's been one of the key reasons we've been so keen to try and understand the key drivers behind the Forum's preferred solution.

Accordingly, it would be useful to have a project status timeline/milestone confirmed for the EWL from project inception to construction. Obvious milestones would be:

- Project inception July 2014
- Preliminary investigations July to September 2014
- Route confirmation/ protection December 2014 (route confirmation; protection in 2015/16 subject to funding)
- Scheme assessment Detailed Business Case by June 2015
- RMA procedures dependent on preferred option (no sooner than 2015/16)
- Funding to be confirmed by May/June 2015
- Construction Start (sod turning) depends on preferred option
- Construction completion (ribbon cutting) depends on preferred option

In order to make progress as fast as possible, we are also keen to start drilling into the point-by-point details/rationale supporting the Business Forum's proposal. A lot of this detail is in the material sent earlier.

#### Accelerated East-West Link project – "strongly endorsed"

The preferred option of a new road on the north side of Mangere Inlet between SH1 at Mt Wellington and SH20 at Onehunga for the long-discussed East-West Link has been strongly endorsed by the Auckland Business Forum.

Forum chairman Michael Barnett said improved connections for freight in Auckland's industrial hub of Onehunga, Penrose and Southdown had been identified as of 'highest priority' since at least 2010.

"Congestion in the area occurs every working day and 10 minute trips on local roads were regularly taking 40 minutes and sometimes longer.

"Now that NZTA and Auckland Transport have agreed on a preferred route, I strongly encourage them to progress the project as rapidly as possible. As part of the Auckland Accelerated Projects package announced by the Prime Minister in 2013, we are anticipating a work programme that will see completion no later than 2020," he said.

While this project is about improving freight and general traffic access into and out of the Southdown-Onehunga industrial area, the Forum will be encouraging the finalised route design to future-proof for eventual connection to AMETI at Panmure and the East Tamaki business area. This link will also greatly improve access across Auckland between the eastern suburbs and the Auckland airport area for all of those cars and buses forced to travel through the congested Neilson Street area.

The Onehunga, Southdown, Penrose area generates around 18% of Auckland's GDP and over 64,000 people are employed. Many of New Zealand's largest distribution and logistics facilities are located there because of access to both state highways and connections to the rail network. Projections are for a big increase in heavy truck access as the Auckland economy grows.

Given the national significance to the economy of the activity in the area, funding concerns should not restrict the design, consenting and construction by NZTA of a complete solution covering freight as well as cars and buses and which can be consented and built with speed and urgency, said Mr Barnett. "A partial solution would not be acceptable," he said.

## Freight focus on preferred SH1-20 East-West Link - "strongly endorsed"

National Road Carriers chief executive David Aitken has strongly endorsed the preferred option confirmed today by the NZ Transport Agency (NZTA) and Auckland Transport for the East West Connections project to improve freight connections into and out of the Onehunga-Southdown-Penrose industrial hub.

The preferred route is for a full connection on the north side of the Mangere Inlet between SH1 at Mt Wellington and SH20 at Onehunga.

The preferred route will comprise a new 'limited access' state highway (not a motorway) that follows the northern Mangere Inlet foreshore from the SH20 Gloucester Park Interchange and links up with the Southern Motorway at Mt Wellington via Sylvia Park Road.

"It is excellent news that NZTA and Auckland Transport have agreed that a patch-up involving existing roads and traffic lights would do nothing to improve freight efficiency and road safety, and have instead selected a new route option specifically focused on improving freight access into and out of Onehunga-Southdown," he said.

"With heavy congestion on local roads most working days and expectations that freight and truck activity will double over the next 20 years, we believe design and build of a single, integrated freight corridor that has seamless connections to the existing network (SH1 & SH20) as soon as possible is critical.

With today's announcement he anticipated a fast transfer of focus into the next steps of the project consent, design and construction - especially given the announcement two years ago by the Prime Minister that East-West would be its next major focus for improving the Auckland transport network.

Mr Aitken noted that businesses in the industrial suburbs along the northern edge of the Mangere Inlet are home to logistics businesses that employ around 64,000 people (second only to central Auckland) and make a critical contribution to the Auckland and national economy.

"Freight moves the Auckland and New Zealand economy. The road network linking the freight distribution companies located around Southdown and Onehunga with the rest of Auckland is critical to the efficient functioning of Auckland's day-to-day economy, as are the daily freight trips that are generated from this area that service the provincial centres of Auckland's neighbour regions."

National Road Carriers would be keeping a close eye on the projects progress, especially the design detail to ensure efficient, safe access to companies in the area from the new the east-west foreshore route, concluded Mr Aitken.

Following on from our meeting on Monday, please find attached a copy of the original Investment Logic Map (ILM) that was developed for this project (formerly referred to as MMEWS) in November 2012. The ILM has since been updated to include Outcomes and Strategic Responses, which have been mapped to the Problems and Benefits. For those unfamiliar with the ILM and what it is meant to illustrate, the ILM is intended to be a one page visualisation of the investment story which can be readily understood by the layperson. The Problems are the key high level issues that we care about and are couched in cause and consequence statement. The Benefits represent the values that the investment will provide to the investor in addressing the Problems. The percentage number accorded to each of the Problems and each of the Benefits denotes the relative significance of each (note the numbers in each if the columns adds to 100) and indicates a high level priority for which problems/benefits are most important to the investor(s). The work that we have completed up to now has been attempting to confirm the scale and significance of the identified problems and provide a better understanding of how, through our response, we can best give effect to and realise the benefits. 
