Official Information Act Request

Thank you for your request of 27 January 2025, under the Official Information Act 1982, for the following information:

This request is pertaining to the internally assessed Mathematics and Statistics Achievement Standards 91944 *and* 91945 *for the* 2024 *school year.*

For both 91944 and 91945, please provide data for:

(1) How many submissions were made by schools for external moderated by NZQA for the standard, and how many individual pieces of student work did this comprise
(2) How many moderated submissions received each outcome of 'Consistent', 'Not yet consistent', and 'Not consistent'

(3) For each of the grades Not Achieved, Achieved, Merit, and Excellence, how many of each grade was awarded by assessors and how many were agreed with by the moderator (4) What percentage of grades awarded by the assessor were downgraded from a passing grade (Achieved or higher) to Not Achieved

(5) How many submissions by schools used an assessment task developed by the school, and for how many of those submissions was the task deemed by the moderator to "... provide learners with the opportunity to meet the standard".

(6) How many submissions by schools used assessment task developed by a subject association (if the specific subject association is known, please break the information down by subject association), and for how many of those submissions was the task deemed by the moderator to "... provide learners with the opportunity to meet the standard".

Your request has been considered under the Official Information Act 1982.

When considering the above response, please note:

- In 2024, the selection of standards differed significantly from previous years. A larger number of standards were chosen at Level 1 to support the introduction of new standards, which were implemented for the first time following the Review of Achievement Standards.
- External moderation outcomes are outlined on the NZQA website and can be found <u>here</u>.
- The method of sampling student work has also recently changed and is no longer random. The new method of selection is outlined on the NZQA website and can be found <u>here</u>.
- Reasons for disagreement and moderation insights will be published in a National Moderator's Annual Report for Mathematics and Statistics in March 2025. This information is not yet available as it is still in development.
- NZQA referred both these standards to the Ministry of Education to consider as part of their regular standards Review and Maintenance Programme to address the issues we were identifying through national external moderation. As a result, changes were made to both standards for 2025.

³ 'Own' relates to the school describing the activity as being self-developed but often it is an adapted activity from other sources.

⁴ *Blanks*' refers to either materials not submitted, broken links, incorrect passwords or not being able to be read by the moderator.

⁵ *'Did not require moderation*: NZQA only moderates materials if issues are identified in verifying assessor judgements on student evidence.
