On 17 August 2015 you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

 Any advice documents relating to the Child Protection (Child Sex Offender Register) Bill, including briefs, Cabinet Papers, Cabinet Minutes, regulatory impact statements, or other documents.

I apologise for the delay in responding to your request for information.

Hon Anne Tolley, in her capacity as Minister of Police and Corrections, proposed the establishment of a child sex offender register in 2012. The 2012 White Paper for Vulnerable Children established a need for better monitoring of high risk offenders against children. The intent of the Child Protection (Child Sex Offender Register) Bill is to reduce the risk of serious harm to children from known child sex offenders living in the community.

Although the Child Sex Offender Register is within the mandate of the Vulnerable Children's Board, this is a recent development, and the Ministry of Social Development has not been a lead agency in establishing the register. Minister Tolley, in her capacity as Minister of Police and Minister of Corrections, tasked these departments with jointly conducting the work required to establish the register. The Ministry of Social Development was consulted over the process, along with other government agencies.

Minister Tolley became the lead Minister for the Bill in July 2015, when the Register was also placed under the mandate of the Vulnerable Children's Board.

The following documents have been assessed as in scope of your request, however they are withheld under section 9(2)(g)(i) as they contain free and frank advice from Ministry officials to Hon Anne Tolley, Minister for Social Development and her predecessor Hon Paula Bennett, regarding the development and implementation of the Child Sex Offender Register.

The release of this information is likely to prejudice the ability of government to consider advice and the wider public interest of effective government would not be served. I believe the greater public interest is in the ability of individuals to express opinions in the course of their duty.

Please note that some information has been removed from the Cabinet paper and the aide memoire because it is out of scope of your request.






Proposal

- This paper seeks Cabinet's agreement to proposals to streamline social sector leadership and accountabilities in respect to a range of child and youth-related work. The paper proposes widening the mandate of the Vulnerable Children's Board (VCB) to be accountable for the:
 - Children's Action Plan
 - Social Sector Trials
 - Youth Crime Action Plan
 - Child Sex Offender Register.










Child Sex Offender Register

- The introduction of Child Harm Protection Orders (CHPOs), supporting the Children's Action Plan, were proposed as part of the draft Vulnerable Children Bill. These new Civil Orders would have imposed conditions on people considered to be at high risk of abusing children whether they had been convicted or not.
- 28 Given the range of other protective measures the Government was introducing, such as the development of a child Sex Offender Register, it was considered that improved protection of children would be achieved without the need for these Orders.
- The Child Sex Offender Register will contain a range of up-to-date personal information about registered child sex offenders on a secure database. Offenders convicted of a qualifying child sex offence will be required to report annually to Police to confirm their details and to Police or Corrections whenever the details provided change. A dedicated unit of Police and Corrections staff will use this information to provide risk assessments and intelligence products to inform the Corrections and Police staff managing and monitoring these offenders in the community. This information will assist staff to manage the risks presented by child sex offenders and potentially prevent re-offending. The registered offender's period on the register will depend on the offence for which they were convicted and the sentence received. For the majority of registered offenders the monitoring and risk management will continue beyond the end of their sentence.

- Authorised Police and Corrections staff and authorised staff from specified agencies such as Child, Youth and Family, the Ministry of Social Development, and Housing New Zealand, will be able access and exchange relevant information, allowing them to work together in the interests of public safety. The Commissioner of Police will be authorised to share information from the Register with overseas law enforcement agencies which have corresponding registers and offences. New Zealand citizens who commit corresponding offences while overseas, and anyone convicted of a corresponding offence overseas who intends to reside in New Zealand, will be required to register.
- I propose that the Child Sex Offender Register come under the responsibilities of the VCB, with the Ministerial Oversight Group, chaired by the Minister for Social Development.
- 32 This arrangement does not affect the powers exercised by the Minister of Police.
