Thank you for your email of 2 September 2015, in which you requested the following information:

For each of the seven unsuccessful cases [where the Minister at the time did not give approval for the school to open on Saturday/Sunday as requested],

- A copy of the request from the school to the Minister
- Any and all internal documentation that dealt with the request (e.g. recommendations from the Ministry to the Minister)
- A copy of the response from the Minister to the school.

Your request has been considered under the Official Information Act 1982 (the Act).

When a school makes an application to open on Saturday or Sunday, we consider a number of factors including the educational value of the activity for which the opening is requested; the planned programme of learning, and the length of the programme; whether teachers are teaching, or merely supervising students; whether attendance is compulsory; and the impact this would have on students and their families.

Schools' unsuccessful requests, and responses from the Ministry or the Minister

I am providing you with the following applications from schools to open on Saturdays or Sundays, and the responses to the schools (which were sent either from the Ministry, or the Minister):







I wish to request permission for teaching staff to provide a curriculum programme at McKenzie Residential School on six Saturday mornings during .

McKenzie is a Residential Special School catering for 29 Year 3 to Year 8 pupils whose chronic and extreme emotional, social and behavioural difficulties mean their needs cannot be met in their local situation. Pupils are enrolled for a maximum of 4 school terms

Being a Residential Special School prost pupils are on site during weekends and we are providing a programme for pupils in residence at that time.

The presentation of a curriculum programme on these mornings would allow the school to meet its legal requirement of 394 half days and close 3 days earlienal the end of the lear.

Our experience (sthet) short weeks in this situation are less productive and seem to dispapt the rhythm of curriculum delivery.

The shortweek at the end of the year is even more so in this category, as both pupils and teaching staff are low in energy and motivation and it requires considerable effort to maintain productivity.

The school has consulted widely on the matter of the presentation of the curriculum during 6 Saturday morning programmes during the year.

The consultation process has involved the following and has found favour with all parties.

Board of Trustees: The matter has been fully discussed at 2 board meetings (January and February 2006) with the unanimous decision that the matter should be pursued.

Teaching staff: This involves 8 individuals including the Principal. All have discussed the idea fully and with one exception, have provided written confirmation of their willingness and availability to teach on Saturday mornings. The one exception has a long-standing regular Saturday commitment which must be honoured.

Staff in other areas of the school's operations are also in favour as the earlier close down will not only advantage pupils but will also allow more time for those staff to carry out their end of year cleaning, organization and close down duties.

Parents: All 24 parents whose children will be involved have been consulted by phone and letter.

Local parents who will be most affected by this proposal have also had the opportunity for discussion on site.

Twenty one parents have responded (13 by post and 8 by phone) 100% are supportive of the concept and carried the advantages of it. The three parents/caregivers who have offered no opinion can be casual and are difficult to contact at times. If they held a strong view one way or the other, contact would have been made.


In summary, 87.5% of parents and caregivers support the proposition.

Pupils: All 7 local pupils who return home every riday after school were keen to be involved when the idea was discussed with them. Local pupils are always interested in what happens at the school on weekends and are enthusiastic about being involved in this venture.
Full time residential pupils are relaxed about the change this would bring to their usual Saturday morning routine.

There has been considerable thought given to maximizing the benefits. An example of this is that the curriculum could be presented on the Saturday following Queen's Birthday thereby giving pupils a 4 ½ day academic week. We same could apply following Labour Weekend.

You can be assured that the wellbeing and progress of pupils are our priorities as we know that pupils do best when their environment and programme are in balance.

I would be more than willing to provide additional information if requested and in the meantime appreciate your consideration in this matter and look forward to a positive response.

Thank you for your letter of April 15 seeking permission to open McKenzie Residential School for instruction on Saturday mornings during 2000 and 2007.

I have been advised that you have been unable to achieve full agreement with all interested parties in the course of the consultation you undertook in support of your application. In particular, the New Zealand Educational Institute (NZEI) is opposed to your proposal on principle. It is concerned to maintain the provisions detailed in section 2.9 of its collective agreement. For that reason, I must decline your application to open McKenzie Residential School for instruction on specified Saturday mornings during 2006 and 2007 and to close the school early at the end of those years by the equivalent number of half days.




Therefore we would like to formally ask for your permission to open the school on two weekend days next year and count these as part of the official school year.

Thank you for your letter of 20 September 2007 requesting permission for Fernridge School to be open on two weekend days in 2008 as part of the school year.

The key phrase in the Education Act 1989 (the Act that has to be considered in an application such as yours is whether or not the school can be regarded as being 'open for instruction' on the days you specify. While no one doubts the value of events such as pet days and galas, the fact is that on such days the school is not open for instruction'.

The Act also specifically states that schools must be closed on Saturdays, Sundays and statutory holidays and while extra-ordinary circumstances might mean that an exemption would be granted, we come back to the fact that the school would not be 'open for instruction'

A board of trustees may exercise the flexibility to close a school for teacher-only days, local gala or show days and in service training days for no more than three days in a school year. Schools have more flexibility to do this in 2008 since they have greater flexibility to set their own opening dates. However, this flexibility applies to school days (week days) only and primary schools must still make sure that they are open for at least 384 half days in 2008, like all other primary schools.

I am sure all of Fernridge School's community will enjoy the days you are planning, whether or not they are held on Saturdays or Sundays, and I acknowledge the value of those days. However, I cannot approve your request to count weekend days as part of the prescribed school year.

As you know, we are a school of Special Catholic Character, where instruction in Religious Education is one of our required curriculum areas. Thank you for your letter of 21 October 2009 concerning days the school is open for instruction.

I acknowledge your Special Catholic Character and the importance of Religious Education as part of your school's required corrioulum. However, allowing for your request would make attendance compulsory for all students on the mornings in question. This is likely to place an unfair burden on both families and your staff, particularly those who have prior commitments. Your Board would also be required to take action against any truency which accurred. Families would need to be aware of this possibility.

I have decided to decline your request to include the activities of two Sunday mornings as two of the 388 half days a primary school is required to be open in 2009. Please note that this in no way means that you cannot encourage students and families to participate in events on weekends. However these cannot be treated as compulsory school days.

Education Report:

Application from St Theresa's School, Plimmerton to include two Sundays as a School Day.

Purpose of Report

- 1. You have received a letter from the Principal of St. Theresa's School Plimmerton, on behalf of the Board of Trustees, requesting that the Board be approved to include two Sunday mornings that it opens for Parish Mass followed by parent/child activities be included as half days in which it must be open.
- 2. This report provides information about the complexities of the request to include the activities of two Sunday mornings as two of the 386 half days the school is required to be open in 2009.

Background

3. St Theresa's School, Plimmerton is a co-educational contributing school with a roll of 166 students.

The Legislation and Regulations

- 4. Section 650 (1) of the Education Act 1989 (the Act) states every board shall ensure that all schools it administers are closed on Saturdays and Sundays.
- 5. Section 65C (2) of the Act allows for the Minister at any time to prescribe the circumstances in which boards may open the schools they administer, or any of them, on Saturdays of Sundays; and schools may be open accordingly.
- 6. The prescribed length of the primary school year is 386 half days for 2009.


Implications of Request

- 7. The following is a list of concerns regarding the request:
 - Impact on students and their families as a result of compulsory attendance.
 - Impact on staff having to attend on a Sunday.
 - Whether non-attendance would be treated by the school in the same way as it is on a normal weekday.
 - The educational value of parent/child activities and whether this can be considered equivalent to regular tuition.

Ministry Comment

8. Approving the request will make attendance compulsory for all students on the mornings concerned. The Ministry is concerned that this would place an unfair burden on both families and school staff. There is also a risk that truancy issues would arise. Therefore the Ministry recommends that the request is declined.

9. However, should you wish to consider approving the request, the Ministry recommends that a number of issues, including potential industrial ramifications and the nature of the tuition to be delivered on these mornings, be further investigated before such a decision is considered.



Thank you for your letter of 26 January 2011 to the Prime Minister, Richon John Key regarding health and education in New Zealand, and responding on behalf of the Prime Minister to the education suggestions in your letter.

The Education Act sets out the days on which schools can operate. Under the Act, schools are not permitted to open on either Saturdays or Sundays. New Zealand also has one of the highest levels of teaching hours per year in the Organisation for Economic Co-operation and Development (OECD). There are no plans to extend the number of days that schools remain open.

It is important for New Zealand students to learn languages in order to be equipped for living in a world of diverse people, languages and cultures. The New Zealand Curriculum encourages students to participate actively in New Zealand's diverse multicultural society and in the global sommunity. The Ministry of Education does not direct schools to teach a particular language, however, it does provide a range of evidence-based resources and initiatives that support the development of effective and enduring language programmes. As a result, the number of language learners has increased over the past decade, from 140,662 in 2001 to 192,982 in 2010.

Many school boards of trustees already offer breakfasts at school through a number of programmes. One such programme is the New Zealand Red Cross Breakfast in Schools programme which offers children attending decile one primary schools throughout New Zealand the opportunity to eat a healthy breakfast before they start school. It's affect to face, friendly approach to providing a healthy, nutritious breakfast and encourages healthy eating behaviour. The number of schools supported continues to grow and currently over 1600 healthy breakfasts are served through the programme every school day.

Thank you for your letter of 22 February to the Minister of Education, Hon Anne Tolley about your school's open day. I have been asked to reply to your letter directly.

The Education Act 1989 (the Act) allows the Winister some discretion to prescribe the circumstances in which school boards may open on a Saturday or Sunday. However in using that discretion the Minister would need to consider the overall intent of the Act. This would include the requirements under section 65A to remain open for instruction for a specified number of half-days. It is unlikely that holding a school open day could be considered as being open for instruction.

The Minister's discretion is also only likely to be used in exceptional circumstances. Making it easier for your school's teachers to attend an open day would not usually be considered exceptional circumstances.

You may wish to consider scheduling your school open day during normal school hours which would allow the school to provide instruction for those students that are not directly involved.

My name is Anthony Uiterwijk, Principal of Hira School in Nelson.

Earlier today I contacted the Ministry of Education to check whether we sould list one Sunday next month as a school day.

Our school has struggled to get all parents to come to school interviews and reporting sessions, because most of our parents both work and often unusual hours as well.

We would like to organize a "Student Led Conferences Day" similar to the way they do them in IB and other International Schools and use a whole school day for it. (I have worked in an IB School for the last 2.5 years)

We realized that the best way of doing this and ensuring high parental participation as well as improving school/community partnership, would be to do this on a weeken day.

Both students and staff are prepared to organize such a day and we thought it would fit with the minister's ideas about a more flexible school day.

However, our first response from the ministry has been that it could not be counted and approved as a school day.

We find this really disappointing and it is not in line with the Government policy of improving community involvement in schools.

Is there any thing you could do for us or give us an exemption?

The Minister of Education, Hon Hekia Rarata, has asked me to reply to your email of 23 July 2014 about your request to include one Sunday as a school day to increase participation at school interviews and reporting sessions.

As you may be aware the Education Act 1989 sets out the requirements for when state schools must be open. There is a provision for schools to open on a Sunday and have it counted as a school day in certain circumstances. These include that each student needs to be involved in a planned programme of learning for at least two hours for each half day. Teachers would need to teach, not just supervise students during this time.

The Board of Trustees (the Board) can hold events such as parent teacher interviews on a Saturday of Sunday, but it would not be counted as a school day. The Board would need to consider the employment implications for the teachers and staff working, and would not be able to make student or teacher attendance compulsory.

I understand Director of Education for Nelson/Marlborough and West Coast, has contacted you about this. If you have any further questions, please contact who will be happy to discuss it further.
