I've received a call from Michelle Taylor in the Ombudsman's Office regarding our last response to Valerie Morse's OIA for DWP submissions.

I've attached a copy of the letter we sent to Ms Morse in February this year, explaining the delay in the release of the DWP and related submissions. The letter states that publication was intended to occur "in late March 2016". Ms Morse has now gone back to the Ombudsman's Office, and we are being asked to write another letter to Ms Morse with an update and revised timeline for the DWP release.

Is your team able to prepare a response – similar to the last one we sent – explaining the further delay and that we are still very much intending to release the submissions together with the DWP, with a revised timeline for release (if we have one)? It is intended that this occur in late March 2016.

As discussed, I got a call this morning from Michelle Taylor at the Office of the Ombudsman. She was making an initial call regarding a complaint from Valerie Morse. Ms Morse had OIAed for copies of the DWP2015 submissions, and in October we replied saying that these would be made publicly available by the end of 2015.

I advised that we were preparing significant communications about releasing both the submissions and the broader Defence White Paper material, and that this would be done in March. It has always been our expectation to publicly release the submissions – as was the case with the last review – and this would be a comprehensive release.

I said that we would be happy to write to Ms Morse and confirm these details, and that we would do this by Tuesday.

Michelle was happy with this and asked to be copied in to the response (her email address is Michelle.Taylor@ombudsman.parliament.nz). She will call Ms Morse to discuss as well.

Michelle asked if it was possible to separately release the submission prior, but I said these were caught up in the broader communications. She also asked what our rationale for the delay was. I said that it was administrative — to do with preparing the broader comms.
