- 8. The Commission has published a number of documents on national roaming, which can be found on our website, <a href="www.comcom.govt.nz">www.comcom.govt.nz</a>, under Regulated Industries. These include a Review of MTAS as a designated service, a 2013 determination Final Decision of whether to investigate omitting National Roaming from part 3 of Schedule 1, and a Final Decision on review of Schedule 1 services.
- 9. Our website archive also contains a number of publications on national roaming, which can be found on our website under Regulated Industries/Archive.
