Official Information Act 1982 request

I refer to your email of 26 November 2015 requesting, under the Official Information Act 1982 (the OIA):

All correspondence, minutes of meetings, memos, reports, studies, options papers, cost-benefit analyses, agendas, internal rules affecting decisions, briefings, budget bids, submissions, consultants' reports, costings, policy papers or any other resource considered in relation to the refusal to grant exemption to the prediction website iPredict under the Anti-Money Laundering and Countering Financing of Terrorism Act.

Documents within scope

The attached table lists the documents that fall within scope of your request and contains details of the information released to you. Only information in scope of the request has been provided. As indicated in the table, documents or parts of documents have been withheld to protect the privacy of natural persons (section 9(2)(a)).

Where the information is publicly available, that part of the request has been refused under section 18(d) of the OIA. Other parts of the documents have been released to you.

Where information has been withheld under the OIA I am satisfied that there are no other public interest considerations that render it desirable to make the information available.

You have the right under section 28(3) of the OIA to complain to the Ombudsman about the decision to withhold some of the information requested.
