School Donation 2015.

Welcome to the 2015 academic year. Following on from the letter regarding start of year organisation, this letter is about our school donation – a media taking point as school starts.

Please take a moment to read the following carefully and we would appreciate you following the instructions on page two.

As a parent at Grammar, you will realise that the donation is not a luxury the School can do without. With state funding falling further and further behind, the donation is the most important contributor to the School's annual operating income. It means we can keep providing the quality education our families currently enjoy for their sons.

The Board of Trustees has set the parental contribution for attendance at Auckland Grammar School in 2015 at \$1075.00 per student (\$2150.00 for two or more boys).

Why donations are so important

- Without the income generated by the parent donations each year Auckland Grammar School would struggle to operate
- Auckland Grammar School is a Decile 9 school which puts it at one of the lowest possible levels
 of funding from the Government
- Auckland Grammar School receives \$932 less funding for each student than the government's operational funding available to a Decile 1 school of the same size.
- Operational funding from the government is expected to cover learning resources (books, equipment, and classroom materials), support staff salaries, professional development, maintenance of buildings and grounds and all information technology and administration costs. However every year this government money has to be augmented by locally raised funds.
- Less than half of the Auckland Grammar School annual operating budget is funded from government grants. The remaining income is "locally raised" and school donations from parents contribute 40% of this locally raised income.

Generous parent financial support over many decades has helped make Auckland Grammar School the pre-eminent state school it is today. Your contribution for 2015 will ensure the continuation of the quality learning experiences for which our School is renowned.

Government funding to Auckland Grammar School is \$932 per student less than that paid to a Decile 1 school. This implies an expectation from the Government that parent support will bridge this gap. By passing this onto parents in the form of a donation we afford to parents the tax benefits of one third of the payment and minimise the multitude of subject and course charges passed on by other schools.

While the 2015 contribution eliminates most compulsory payments for academic subjects, payments for some items such as subject work books and special competitions will still be required. The Form 4 Outdoor Education experience at Venturelodge is an example of an additional cost.

Easy payment options

To make it as easy as possible for you to donate, the School offers different payment options to suit—whether it is via a lump sum or monthly amounts. While lump sum payments are best for the School, you are also welcome to commence a monthly payment arrangement of \$107.50 per month from February through to November. An Automatic Payment authority form is enclosed for you to complete and send to your bank should you wish to take up this option. While we encourage your use of the Parent Portal other payment options are detailed on the attached sheet.

Payment can also be lodged with the Finance Office by mail or in person at any time.

All donations are tax deductible

We ask that you continue to support Auckland Grammar School and in so doing contribute to the provision of a quality education for your son and all young men at Auckland Grammar School. A receipt will be issued for all contributions received and contributions are income tax deductible.

If you have questions or comments for the School, please write them on the form enclosed and return it to us. Likewise, if we do not have your correct details, including your address and payment details, please let us know.

Thank you again for your on-going support. Together we look forward to the challenges, opportunities and rewards that 2015 will bring.
