Organ Donation in ICU / CCU (District)

This policy outlines the potential donation of organs following brain death of a patient in the Intensive Care Unit (ICU) Dunedin Hospital and Critical Care Unit (CCU) Southland Hospital.

Policy Applies to

This policy is for all nursing and medical staff employed by Southern District Health Board (Southern DHB) working in ICU at Dunedin Hospital and CCU at Southland Hospital, including full-time and part-time workers, as well as students and contacted clinical personnel.

Policy Statements

Whenever an ICU / CCU patient may be a potential donor, the reference document 'Guidelines for Organ and Tissue Donation' (in the 'Organ Donation' folder) is to be followed.

All organ donation is undertaken via the ICU / CCU.

All resources, material, and contact numbers are held in the ICU / CCU.

Tissue donation is an option outside of the ICU / CCU. For further information, please contact the charge nurse manager (CNM) in ICU / CCU or phone the donor co-ordinator 0800 4 DONOR (0800 436 667).
