**Local Government Official Information and Meetings Act 1987**

Thank you for contacting Auckland Transport on 1 March 2016 requesting the following information in relation to Victoria Road, Devonport:

- 1. Seek any information relating to pedestrian count and any related traffic data/ reports from AT Auckland cameras installed at both 149 Victoria Rd Devonport and 159 Victoria Road Devonport. Camera operation 15 thru 17 February 2016.**

Auckland Transport did not install the cameras in the locations referred to and we therefore do not have any data relating to these surveys. This survey was conducted by Traffic Engineering and Management Limited on behalf of a third party. If you wish to follow up on this please contact them directly. Your request is therefore declined under Section 17(g) of the LGOIMA as the information is not held by Auckland Transport.

- 2. Request any reports related to application for Butterbee Childcare facility at 159 Victoria Road Devonport.**

This part of the request was transferred to Auckland Council on 3 March 2016 for a direct response in accordance with section 12 of the LGOIMA as this information is held by the Council.

- 3. Request any AT Auckland assessment of Childcare proposal on Bus schedules and safety of bus patrons using bus stop located outside 159 Victoria Rd if proposed childcare facility approved.**

Auckland Transport has no documentation in relation to safety audits previously carried out at 159 Victoria Rd (bus stop 3405). Your request is therefore declined under section 17(e) of the LGOIMA as the information requested does not exist.

- 4. Any traffic accident/incident information for upper Victoria Rd, Albert Road, Ewen Allison Ave immediate area/intersection.**

A search was conducted within the NZ Transport Agency Crash Analysis System (CAS) for all crashes (fatal, serious, minor and non-injury crashes) reported by NZ Police over the past 10 years 2005-2015 (currently in CAS as at 10.03.16) within a 20 metre radius of the Victoria Road, Albert Road and Ewen Allison Avenue intersection.

Within the search criteria, two non-injury crashes were found to have been reported on Victoria Road, one 5 metres south of the intersection with Albert Road and another 10 metres south of the intersection with Albert Road. No crashes within the search criteria have been reported to have occurred within the actual intersection of Victoria Road and Ewen Allison Avenue.

We trust the above information has addressed the matters raised however, should you believe that we have not responded appropriately to your request, you have the right in accordance with section 27(3) of the LGOIMA to make a complaint to the Office of the Ombudsman to seek an investigation and review in regard to this matter.
