Dear Sam

Thank you for your email dated 2 March 2016, requesting information about the construction and expansion of prisons. Your request has been considered under the Official Information Act 1982 (OIA).

You have asked five questions relating to plans for the construction and expansion of prisons. These have been addressed below.

- 1. What are the current building projects of the Department of Corrections, including public/private partnerships?
- 2. Where are new facilities being built, extended, and refurbished?
- 3. How many people will each of the new projects house?
- 4. Will any new facilities be built to accommodate double-bunking?

Information outlining the details of current construction work on prison sites as at 2 March 2016 is attached as Appendix One.

Please note that no new accommodation is being created as a result of these projects. The Auckland East (PPP) will accommodate 260 prisoners, which will replace the existing facilities.

Also, none of the current projects are being built to accommodate double bunking.

5. Please provide any and all construction plans for the above projects.

Construction plans for these projects are commercially sensitive. Therefore, this part of your request is withheld under section 9(2)(b)(ii) of the OIA, to protect information that would be likely to prejudice the commercial position of the person who supplied or who is the subject of the information.

We are also unable to release information about the construction of prisons into the public domain as doing so could compromise the safety of individuals or the security of prisons. Therefore, the requested information is also declined under section 6(c) of the OIA, as the making available of that information would be likely to prejudice the maintenance of the law, including the prevention, investigation, and detection of offences, and the right to a fair trial.

I trust the information provided is of assistance. Should you have any concerns with this response, I would encourage you to raise these with the Department.
