This illustrates the date we send the request to Moto-Chek and receive the information back before uploading and generating a reminder letter to the registered owner.

Since May 2014 – April 2015, Wilson Parking has accessed 168917 vehicle owner details from the NZ 5085 Transport Authority for the MOT approved 'specified purpose'; To send reminder notices to persons registered in respect of motor vehicles where vehicles have been parked in car parks managed by Wilson Parking in breach of the terms of a contract

We certify that the names and addresses obtained from the register have only been used for the specified purpose and there have been no reported instances of unauthorised access. Please find attached (appendix 1) our monthly usage summary.

Before being permitted access to the Motor Vehicle Register, all staff received training emphasising that such access must only be for the 'specified purpose'. Please find enclosed (appendix 2) our Wilson Parking Enforcement Services Division 'Moto-Chek Confidentiality Requirements Acceptance' confirming their understanding and training. Only these staff have access to Moto-Chek.

Access to the register for these staff has been restricted to our central location of Wilson Parking New Zealand Limited's head office located on level 12, SAP Tower, 151 Queen Street, Auckland. Access to the enforcement services division at this address is restricted by proxy-card reader access.

Daily records are kept of the purpose and occasions whenever names and addresses are accessed from the register in our Notice-It Data base with restricted access to the above authorised staff. A minimum five working day delay is applied from the time a breach notice is placed on a vehicle to when we request the owner details from the register. Please find attached (appendix 3) a sample of work-flow files for Moto-Chek requests. This illustrates when a new infringement is added to the system and when the owner request is sent. We have programmed our Notice-It data base system to apply an automated delay of 5 days.
