Thank you for your email of 11 July 2012, asking the following:

'On 2 July 2012 the government announced plans to further amend the Emissions Trading Scheme ("Government announces ETS amendments", 2/7/2012). I would like to request the following information under the Official Information Act 1982: All advice (including briefings, aides memoire, reports and cabinet papers) on the proposed amendments.'

The scope of the request has been interpreted as:

- advice related to the proposed changes to the New Zealand Emissions Trading Scheme (announced on 2 July 2012);
- received by the Minister Climate Change Issues between the date that the New Zealand Emissions Trading Scheme Review Panel's report was published (July 2011) and the date of your request.

Advice that did not directly relate to the announced changes has been considered out of scope, as has advice that related only to the timing of or process for the announcements. Draft versions of documents that have had their final version released as part of this response have also been considered to be out of scope.

Twenty eight documents fall within the scope of this OIA request. Four have been released in full, twenty are being released to you in part and five have been withheld. The OIA provisions applied in releasing, withholding and refusing these documents are explained in the attached document table. Where information has been withheld from a document, the relevant section of the OIA has been noted. Information that has been removed because it is out of the scope of this request has also been clearly marked.

Under s 28(3) of the OIA, you have the right to ask the Ombudsman to investigate and review my decision to withhold some of the information you have requested.
