Since stopping that business one of my dreams was to be a Radio show host and luckily was shoulder tapped to be a show host for Community Zone on Access radio.

I called the Show B-side stories, and it was a natural fit for me to focus on talking to Wellingtonians who are part of the solutions in our environmental and social issues that are going on around our city, with the intention of getting others aware or involved with the good things that are going on in their city.

Over two years we have interviewed over 150 people and groups on B-side Stories, like:

- Conscious Consumers about their accrediting system for cafes who are doing the right thing,

We have now evolved into a team of 5 on the show and have a small wait list of others wanting to join in as show hosts.

We have a great success in sharing the podcasts from the station and our personal Sound cloud has attracted over 10 000 listens as people have not been able to listen on air.

It has been about telling these good stories, and making people see there are solutions going on right here in their community and therefore building a community around this that has been the success.

I believe there would be no other station that could allow this on air community to develop, and allow so many people the opportunity to talk about what they are doing and for others to hear it, and be able to participate too.

But since the day I started broadcasting here have lamented that the station has not had an FM frequency. I believe the numbers listening would be so much higher as these are the repeated comments people have made:

- They listen only to FM and there is a reluctance to change habits
- I myself cannot get AM in the Car
- The perception that FM is more expected now and the question "WHY are you still using AM?
- They have had to listen to the podcast as they could not access the station on an AM frequency on their devices

The benefits would be:

- This would put Access On the map as a serious alternative to the commercial radio stations
- This would evolve into the further success of Access radio as the listenership would increase
- Would attract a greater range of Program makers
- It would have a more positive effect on the community as it would bethe radio of
   Choice and with good shows like B-side stories giving our community a voice goodness knows what positive impact this would have on our city.

The Association of Community Access Broadcasters of Aotearoa is the collective body for the 12 Access Radio stations (largely funded by NZ on Air) and we act as an organisation able to speak on behalf of our membership.

We know Wellington Access Radio plans to submit an application to obtain a non-commercial FM licence and ACAB wholeheartedly supports this move.

While AM is an adequate broadcast medium, the advantages of FM are a better signal, stereo sound and cheaper operational and maintenance costs. Stereo sound, while it may not be seen as essential in some sectors, is essential to ours. Our growth area is in youth broadcasting, and since a great deal of youth culture has a strong music focus it is difficult to get buy-in from potential young programme makers when a broadcast signal remains in AM.

As a long-time listener of Wellington Access Radio, I've been delighted to have had a stronger connection to this organisation over the past year.

Station Manager, Kristen Paterson interviewed me about a series of free public DIY zine and artist book-making workshops I was running with Wellington City Libraries in May 2015, which provided greater outreach to our intended audiences.

Since then, I have been learning more about the good work they do providing community and arts representation through their broadcasting platform. Of particular interest is the 'Community Zone' programmes which showcase grassroots events and organisations and allows for much more diverse voices that that which are currently heard on other FM stations. I've been telling everyone about it!

Kristen's work at Access Radio is engaging and inspiring, so linvited her to be a part of a social art project that I was running called the Porirua People's Library (PPL) (www.peopleslibrary.org.nz) that was part of the recent TEZA; Transitional Economic Zone Actearoa festival (www.teza.org.nz). The PPL is a DIY multi-disciplinary art, design and media storytelling project that operated on the ground with diverse communities in Porirua City to give form to local stories and give voice to a broad cross-section of people who would otherwise not be heard. As an alumna of Whitireia Journalism School, Kristen already had a personal connection to Porirua and was so dedicated in travelling out regularly to interview locals in and around the shops where we were based. As a result she made lots of connections and friendships on the ground and offered a chance for people in the community to hear their own stories re-presented to the world in a fresh way.

Her 'Rorifua People's Radio' open-mic radio workshops were very popular and successful, and Kristen's offering of the mic and opportunity to 'get on air' was relatable and fun. The outputs of this work are catalogued in our online archives here: www.peopleslibrary.org.nz/archives, and will live on in the archives of Porirua City Libraries and Nga Taonga Sound and Vision.
