Search for a missing pig hunter two of whose dogs had returned to his vehicle and found in the vicinity. The dogs had GPS tracking collars fitted which are commonly used by pig hunters throughout the country. Some dogs were possibly still with the missing person.

Problem


We were advised by seemingly knowledgeable people that the only way the collars could be tracked was by using a GPS unit initialized to the individual collars. The only unit in this state was with the missing person.

Resolution

Not only is it possible to track collars with another unit suitably configured, but the collars themselves save the track in their GPS unit, and this can be downloaded. Both of these actions require a person with specialist knowledge and equipment. Most pig hunting clubs have within their membership a person with this capability. Unfortunately these people do not often like to broadcast the fact they can do this. Compounding the situation is the fact these collars contravene the frequency regulations and are illegal. Attached is a map with a track downloaded from one of the dog collars. The missing person's clothing was found at the point where the track entered the river.

- 1. At its meeting of 19 November 2015, the NZSAR Council agreed on the person specification for an additional member of the NZSAR Council to represent the non-governmental elements of the SAR sector, and on the process to appoint that person. The SARINZ report dated 22 December 2015 for the Fiona Mills Coronial Enquiry included some data and associated analysis around missing persons being 'not located'.

Regrettably the information contained in that document is incorrect along with its associated analysis.

The best available information is below. It is drawn directly from the relevant Police and RCCNZ records. All records in our datastore come from Police and RCCNZ, hence are official statistics.

It clearly shows that the numbers are variable, with no obvious trend at all. The claims in the report about the quality of SAR training are erroneous.

The following are details from the NZSAR Datastore for land based SAR incidents over the last five years with 'casualty not located'.

On the table above:

- ✓/Blue rows show the total number of land based incidents by category.
- Red rows show how many of those incidents include 'casualty not located', again broken down by category.
- Yellow rows show how many of those incidents had LandSAR support, again broken down by category.

Of note are the nine category 2 incidents listing 'casualty not located'. All of these actually have duplicated records, as they all were cat 2 incidents where RCC had police support. Only the police records include 'casualty not located' figures, the RCC records do not. The associated category 2 records from the RCCNZ daily reports are briefly summarised below:

- Beacon in boat in driveway
- Beacon in rubbish truck

- Beacon alert from Cessna. Extensive aerial search of route and possible landing strips before confirmation that Cessna is operating normally
- Beacon in tip
- Beacon thrown onto a roof
- Beacon in old car on a farm
- 17 year old beacon in a shed
- Unregistered beacon alert. Hunters at GPS location of the alert denied activating their beacon
- Stolen pack including beacon left next to a river

So - all nine of the Category 2 records listing 'casualty not located' are incorrectly coded. None of these incidents have any not-located persons at risk.

We also believe that some Police SAR Coordinators may record a 'person not located' whenever they carry out a SAROP, even if the investigation shows there was never a person to locate. The data standard project will assist to reduce or eliminate these instances in the future.

The fatalities study will include an analysis of all the records in the data store that include casualty not located'. This will give us a better idea of how many incidents genuinely conclude suspend with people known to be missing.

Additional Risk Register Entry

1. Summary

It is recommended that the following item be added to the NZSAR Risk Register:

(a) Risk Description:

SAROP Management

Perceived or real poor search management resulting in external investigation and/or criticism.

(b) Reasons or Causes:

Dissatisfaction by family, friends or associates of the competency of the search management, and resources used, leading to the engagement of an external agency to comment and criticise publicly.

(c) Consequences:/

- (i) Damage to the reputation of the NZ Search and Rescue community.
- (ii) International bad publicity with respect to New Zealand as a safe destination for adventure tourism.
- (iii) Time and expense to defend performance and refute allegations.

(d) Likelihood:

Possible.

(e) Impact;

Moderate.

(f) Risk Treatments: (Suggestions only - for discussion)

- Assessed regional IMTEX's involving multiple agencies (Police, RCCNZ, LandSAR, CGNZ, SLS) to broaden, update and standardise search management practices. Also to maximise the pool of competent and current regional search managers.
- (ii) Regional assessed SAREXs planned and delivered by an independent provider.
- (iii) Review of randomly or targeted SAROPs by an independent body.
- (iv) Annual evaluation of items **(f)** (i) (iii) to identify training and improvement opportunities.

(g) Post Treatment:

Yellow.

(h) Comments/Examples:

Registration of this risk, and the identification of steps to mitigate, would be a valid tool in the defence of criticism levelled at the sector.

2. Background

In December 2014, an elderly lady suffering from Alzheimer's disease went missing from her rural home. Despite the efforts of a family search and a Category 1 SAROP followed by a private, family funded, search the following month, she (or her body) was never located.

The family subsequently engaged the services of a nationally recognised training provider, with international connections, to critique the Category 1 SAROP and present the findings to the coronial inquiry. This critique represented that there were multiple shortcomings in the management of the Category 1 search. The Police and LandSAR were then put in the position of having to defend their performance, and address the issues highlighted in the report, at the subsequent coronial inquest.

The Coroner's findings have yet to be published but it is expected that, apart from a few items already identified by the post operation debrief, there will be little public fallout from the Coroner's report. In this event it is suggested that, had the items identified for improvement been implemented, they would not have materially affected the outcome of the search. This event does, however, highlight the potential for a wealthy family, possibly from overseas, to engage an international "expert" to produce a damming report on the management and conduct of a search for a lost loved one and make this very public. The consequence of this would be for the sector to be forced to publicly defend and refute the allegations at quite considerable expense and risk to reputation.

With the current paucity in SAROPs that go beyond the "Initial Response" phase comes a lack of operations for search and rescue skills to be exercised. This has led to a range of SAR capability across the country from good to less than desired. It has also led to a decrease in enthusiasm by volunteers in those areas where there is little activity. SAREXs are generally organised, run and debriefed within groups without a benchmark standard to assess performance against. It is suggested that interesting multi-agency exercises, run and assessed by independent providers, would go a long way towards addressing this issue and would provide objective feedback on capability to the provider managements and coordinating authorities.
