Proposal: Hon Dr Nick Smith, Minister for the Environment (the Minister), is seeking your support for an exception to the Cabinet Fees Framework (the Framework) to pay exceptional fees to three members of the Environmental Protection Authority Board (the Board) when they are reappointed with effect from 1 July 2016.

Key points:

- The Board is classified as a Group 3a, Level 4 body under the Framework. The applicable annual fee range is \$12,000 to \$16,960 for members.
- The Minister intends to reappoint Gillian Wratt, Tim Lusk and Nicki Crauford as members of the Board when their current terms end. The Minister proposes that all three members continue to receive annual fees of 1200. This level of fee is consistent with fees paid to the other members of the Board.
- In August 2012, the former Minister of State Services agreed to support exceptional annual fees of 4000 for one new member of the Board based on the Minister's advice that the applicable fee range was insufficient to secure the skills and expertise required for the Board. Subsequent appointments to the Board have been made at this fee level.
- The Framework provides for minor/technical exceptions to be agreed by the Minister of State Services and the responsible Minister without referral to the Cabinet Appointments and Honours Committee (APH).
- In our view, as this exception is cost neutral and was agreed by APH when the original appointments were made, it can be treated as a minor/technical exception.
- We recommend, therefore, that you agree to the Minister's proposal to continue to pay Gillian Wratt. First Lusk and Niski Crauford exceptional annual fees of "() when they are reappointed, without referral to APH.
