Dear Emma Cullen,

I refer to your request under the Official Information Act 1982 (the OIA) received on 30 May 2016 requesting the following information from Immigration New Zealand:

- 1. The number of asylum seekers currently being held in prison.
- 2. The age/gender/nationality of asylum seekers currently being held in prison.
- 3. The length of time each asylum seeker has been held in prison and what prison they are located in.
- 4. The number of asylum seekers currently being held in detention (not living in the community freely).
- 5. The age/gender/nationality of asylum seekers currently being held in detention.
- 6. The length of time each asylum seeker has been held in detention and where they are located.
- 7. The stated reason(s) for each asylum seeker being held in prison/detention.
- 8. The number of asylum seeker applications for 2015, listed by country and approved/declined decision.

Our response

1. The number of asylum seekers currently being held in prison

As at 8 June 2016, there are currently 3 asylum seekers being held in a New Zealand prison.

2. The age/gender/nationality of asylum seekers currently being held in prison.

The 3 asylum seekers currently being held in a New Zealand prison are male.

The age and nationality of the asylum seekers is being withheld under section 9(2)(a) of the Official Information Act to protect the privacy of natural persons. I do not consider that the withholding of this information is outweighed by public interest considerations in making the information available. Section 151 of the Immigration Act 2009 outlines that confidentiality is to be maintained in respect of claimants, refugees and protected persons.

3. The length of time each asylum seeker has been held in prison and what prison they are located in.

This information is being withheld under section 9(2)(a) of the Official Information Act to protect the privacy of natural persons. I do not consider that the withholding of this information is outweighed by public interest considerations in making the information available.

Section 151 of the Immigration Act 2009 outlines that confidentiality is to be maintained in respect of claimants, refugees and protected persons.

4. The number of asylum seekers currently being held in detention (not living in the community freely).

As at 8 June 2016, there are currently 9 asylum seekers being held in detention. This includes the 3 asylum seekers currently being held in a New Zealand prison.

5. The age/gender/nationality of asylum seekers currently being held in detention.

The six asylum seekers, who are currently being held in detention, excluding the three asylum seekers currently being held in a New Zealand prison, are male.

The age and nationality of the asylum seekers currently being held in detention is withheld under section 9(2)(a) of the Official Information Act to protect the privacy of natural persons. I do not consider that the withholding of this information is outweighed by public interest considerations in making the information available.

Section 151 of the Immigration Act 2009 outlines that confidentiality is to be maintained in respect of claimants, refugees and protected persons.

The length of time each asylum seeker has been held in detention and where they are located.

This information is being withheld under section 9(2)(a) of the Official Information Act to protect the privacy of natural persons. I do not consider that the withholding of this information is outweighed by public interest considerations in making the information available.

Section 151 of the Immigration Act 2009 outlines that confidentiality is to be maintained in respect

of claimants, refugees and protected persons.

7. The stated reason(s) for each asylum seeker being held in prison/detention.

The nine asylum claimants are being detained because they meet the provisions of s309 of the Immigration Act 2009 – *Persons liable for arrest and detention*. Immigration New Zealand (INZ) applies to a district court for warrants of commitment seeking detention while refugee claims are being processed. No person with an undecided refugee claim can be deported before the claim is declined and the person has exhausted all their legislative appeal rights. INZ reviews the detention status of asylum claimants on an ongoing basis and adjusts detention status on a case by case basis taking the availability of new information into consideration. Persons who are liable for detention under the Immigration Act 2009 can be detained for a number of reasons, including, concerns regarding their identity, documentation or character issues, possibility of flight risk, public interest factors, criminality or security concerns.

8. The number of asylum seeker applications for 2015, listed by country and approved/declined decision.

Some information has been provided as a summarised total under "other" in reliance on Section 18(c)(i) of the OIA.

The table below provides information on the number and nationalities of asylum seeker claims lodged with the Refugee Status Branch of Immigration New Zealand in 2015.
