Dear Tony

I refer to your Official Information Act request of 18 July 2016 for information on the location of all red light and fixed speed cameras.

You requested:

A full list of all red light and fixed speed cameras through the whole of New Zealand, including their location, either in form of actual street/road address, or as a CSV file of locations listing their longitudes & latitudes.

In Police's response dated 7 July 2016, to the request of 17 June 2016, Police provided you with information that shows the locations of the fixed speed camera sites by road segment. As mentioned in our response, Police is concerned that the publication of the precise location of fixed speed cameras may trivialise or sensationalise high speeds and potentially create an environment where people may speed everywhere but where the cameras are. Identification of the precise location may also lead to camera infrastructure being damaged. We also noted that despite their name, fixed speed cameras are mobile and are regularly rotated between different sites within a Police district.

As mentioned, the information on the location of fixed speed cameras throughout New Zealand has already been provided to you and is now published online at https://fyi.org.nz/request/4152-location-of-all-fixed-speed-cameras-across-new-zealand. Therefore your request is refused pursuant to section 18(d) of the Official Information Act 1982, in that the information requested is publicly available.

You are now requesting the location of all red-light cameras in New Zealand. As this is additional to your request of 17 June 2016, Police have considered this as a new request under the Official Information Act 1982, with a due date of 15 August 2016.

Details on the locations of New Zealand Police owned and operated red-light cameras can be found on our website, http://www.police.govt.nz/advice/driving-and-road-safety/speed-limits-cameras-and-enforcement/speed-cameras#anchor4. To assist you, table 1 provides the location details of the three Police owned red-light cameras.

Please note, Auckland Transport (AT) also owns and operates red-light cameras and sites. Like Police's speed cameras, AT's red-light cameras are mobile and are subject to rotation between different sites. There are 15 red light camera sites owned by AT. Table 2 provides the location information Police holds on each of these sites.
