Official information request for investigator's contract for the Investigation into the Possible Unauthorised Disclosure of Information Relating to the Ministry of Foreign Affairs and Trade (the Investigation)

I refer to your official information request dated 23 June 2016 for a copy of Dame Paula Rebstock's contract to lead the Investigation.

The information that you have requested is enclosed (a letter dated 8 May 2012, entitled "Investigation – Ministry of Foreign Affairs and Trade"), subject to information being withheld under one or both of the following sections of the Official Information Act 1982 (OIA):

- section 9(2)(a), to protect the privacy of natural persons, including that of deceased natural persons
- section 9(2)(b)(ii), to protect the information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.

In making my decision, I have considered the public interest considerations in section 9(1) of the OIA.

You will note that on 23 May 2012 I amended the Investigation's terms of reference to ensure that the scope of matters being investigated was sufficiently wide.

The letter of delegation and the terms of reference referred to in the letter dated 8 May 2012 are withheld in full under section 18(d) of the OIA, on the grounds that the information requested is or soon will be publicly available. The documents, including the amended terms of reference dated 23 May 2012, are available in Appendix A of the Report on the Investigation on the State Services Commission's website (http://www.ssc.govt.nz/report-unauthoriseddisclosure-mfat-papers). Dame Paula's total remuneration for leading the Investigation. \$208,916.79, is also publicly available (Hansard from 19 February https://www.parliament.nz/en/pb/hansard-debates).
