Official Information Act request relating to the ChristChurch Cathedral Working Group

I refer to your Official Information Act 1982 (the Act) request received on 14 July 2016. You requested the following:

"... a copy of the terms of reference and any other relevant documents or briefing papers relating to the working party set up to examine the future of the Christchurch Anglican Cathedral."

On 21 August 2016 you were advised that your request was interpreted to mean "significant documents, for example, where a decision was made or agreement come to, instead of, for example, administrative emails that don't deal with the substantive issues or phases of setting up the working group".

I apologise for the delay in response to your request.

I am releasing the documents listed below, subject to information being withheld as noted. I note that your request captures a number of iterations of the Terms of Reference and that the Final Terms of Reference, Document 9, is the only correct version. The other iterations differ slightly with regard to some of the dates mentioned.

The relevant grounds under which information has been withheld are:

- section 9(2)(a), to protect the privacy of individuals; and
- section 9(2)(f)(iv), to maintain the confidentiality of advice tendered by or to Ministers and officials.
