I have never seen that letter, the communication around the possibility of a sponsored fellowship cams from Sally Langley who is President of NZAPS. On Friday I had a telephone conversation with **Angela Kenealy** | Press Secretary | Office of the Hon Dr Jonathan Coleman about the fact that this letter had come in, but the who and where were not discussed. I reiterated to Angela that we need to do some basic service sustainability work prior to suggesting that the gender reassignment surgery service was viable (numbers, funding, multi-disciplinary support etc). Later on Friday I had a very productive talk with a kiwi who trained in the US as a plastic surgeon and who has experience with transgender surgery (although he emphasised he is not a specialist in it!) who could provide collegial support and help develop and support the network of clinicians providing the support surgery etc. His issue is he needs one year of supervised practice to gain his vocational registration in NZ but he would be too good an asset to lose. This doesn't help find the letter but the context is becoming defined?

Ailsa.

I have used my contacts in HWNZ (Tony Crane) to ask about what existing mechanisms could/should be explored to assist this. His opinion is of course preliminary and off the cuff but there is an Advanced Training Fellowship process for circumstances such as these and he gave an example of a fairly similar circumstance involving provision of emergency obstetric surgery in West Coast. This would need the support around numbers and sustainability etc, a DHB of service etc.and support network as we had already identified. I believe strongly that as much as possible this should be kept within existing processes rather than making an overly special case (acknowledging need and desirability of the service but making sure we don't set a precedent).

Two bits to this.

- 1. At select committee MoH was asked to start scoping up the supply/demand/clinical sustainability elements of gender reassignment surgery in New Zealand. This follows the retirement of Peter Walker in Chrictchurch who was performing some of this, male to female. Female to male has remained something that is purchased and performed overseas. As you know this is currently under high cost treatment pool with limited numbers funded and a growing waiting list which was of interest to the committee. So we need to think about how this evaluation is going to be done. I don't recall a timeframe from the committee but may be in their minutes.
- 2. I have been contacted by John Keneally, a plastic surgeon at Counties Manukau. They have a plastic surgery trainee who is interested in the genito-urinary field and they have been thinking about a suitable one year fellowship that could do. This would be in Belgium (one of the places we have used for female to male surgery), Thailand and the US. On completion would be able to replace Peter and also have skills in the wider range of surgery in the genito-urinary area. They have had a some preliminary discussions with Belgian and Thai surgeons and also worked closely with other Auckland regional DHBs and specialties there. Other DHBs perform other parts of the surgery, notably breast routinely, though I am not clear if it is consistent. He told me they successfully ran a similar fellowship for Jonathan Heather who has returned to take up burns surgery. There was a hunt for funding of the fellowship in the conversation.
