Thank you for your email of 20 August 2016, requesting the following information under the Official Information Act 1982:

All internal and external communication between employees and contractors of MBIE and Christchurch City Council employees or contractors relating to consent CD Moorhouse BCN/2016/2332

A search of the Ministry of Business, Innovation and Employment's information systems has produced 21 documents that fall within the scope of your request.
