Dear Amit Kakroo

I refer to your request under the Official Information Act 1982 (the OIA) received on 20 October 2016 requesting the following information:

We have collated both your individual requests under the Official Information Act 1982 into one as follows:

The number of resident class visas issued in the last three years based on offers of employment from Concentrix Corporation and include the following details: The nationality of the applicant, ANZSCO code of occupation, previous temporary visa types held by each applicant and whether they were onshore or offshore when approved residence.

On 03 November 2016 we sought clarification in regards to the legal entity 'Concentrix Corporation', to which you confirmed it was intended to be Concentrix Services (New Zealand) Limited.

Our response

The information is provided in Appendix A.

In regards to your request to disclose previous temporary visas held by each applicant and whether the applicant was onshore or offshore when they were granted residence is refused under section 18(f) of the Act as the information could not be made available without substantial collation or research which would require staff to manually review each file. Providing this information would remove Ministry staff from their core duties and therefore the greater public interest in the effective and efficient administration of the public service would not be served. I have considered whether the Ministry would be able to respond to your request given extra time or the ability to charge for the information requested. I have concluded that, in both cases, the Ministry's ability to undertake its work would still be prejudiced.

I trust you find the information helpful. You have the right to seek an investigation and review of my response/decision to withhold information by the Ombudsman, whose address for contact purposes is:
