

If the display is in an Urban Fire District, you must notify New Zealand Fire Service at least 5 working days before the date of firing to ensure it is loaded into the NZ Fire Information Unit (refer to www.fire.org.nz).

You must notify WorkSafe New Zealand at least 3 days before the date of firing (refer to www.worksafe.govt.nz).
