On 29 November 2016 you emailed the Ministry requesting, under the Official Information Act 1982, the following information:

- *I wish to request all documentation, electronic records and correspondence between the Ministry and Lynley Reid Ltd covering the period 1 January 2013 to present.*

Lynley Reid Limited is a company which owns a McDonald's restaurant franchise in Kaitaia, Kerikeri and Kaikohe. The Ministry provides Flexi-Wage subsidies to Lynley Reid Limited. Further information about Flexi-Wage is available on the Ministry website at: [www.workandincome.govt.nz/employers/employ-staff/flexi-wage.html](http://www.workandincome.govt.nz/employers/employ-staff/flexi-wage.html).

Please find enclosed copies of emails and documents between the Ministry of Social Development and Lynley Reid Ltd from 1 January 2013 until 29 November 2016.

I understand you have already received documentation regarding a specific individual who was employed by Lynley Reid Ltd. This information has not been provided again in this response.

You will note that the names of some individuals are withheld under section 9(2)(a) of the Official Information Act in order to protect the privacy of natural persons. The need to protect the privacy of these individuals outweighs any public interest in this information

A small amount of information has also been withheld, from the following document, under section 6(c) of the Act where making that information available would be likely to prejudice the maintenance of the law, including the prevention, investigation and detection of offences.

You may note that a concern was raised about staff receiving correct breaks at Lynley Reid Limited. A Work Broker discussed this concern with Lynley Reid Ltd and

the owner/operator of the company asked the Work Broker to talk with her if any other issues came to light. The Work Broker was not made aware of any other issues.

The principles and purposes of the Official Information Act 1982 under which you made your request are:

- to create greater openness and transparency about the plans, work and activities of the Government,
- to increase the ability of the public to participate in the making and administration of our laws and policies and
- to lead to greater accountability in the conduct of public affairs.

This Ministry fully supports those principles and purposes. The Ministry therefore intends to make the information contained in this letter and any attached documents available to the wider public shortly. The Ministry will do this by publishing this letter and attachments on the Ministry of Social Development's website. Your personal details will be deleted and the Ministry will not publish any information that would identify you as the person who requested the information.

- B. This employment will be full time (for 30 hours or more per week) or part time for people who have been assessed as having a part time work requirement.
- C. The Subsidy paid under this Agreement is made under the authority of the Cabinet and Ministerial Guidelines for Employment Assistance.
- D. This Agreement includes the Flexi-Wage Subsidy Agreement and the following Conditions of Agreement.

#### The parties agree as follows:

1. Work and Income agrees to pay the Employer the Subsidy for the period and on the conditions specified in this Agreement unless the parties both agree to a variation in writing.
2. The Employer accepts that the Conditions of Agreement apply to the Employee referred to and the agreed hours and rate of pay.
3. If the Employee is paid for less than the hours stated per week, other than for reasons of illness, accident or as agreed in the Conditions of Agreement, Work and Income may refuse payment or make appropriate deductions of the payment to the Employer under this Agreement for that week.
4. The Employer will not be entitled to receive any payments under this Agreement in respect of the Employee where funds or subsidies have been provided from any other source to the Employer for the employment or training of the same Employee for the same period of employment or training (without prior written approval by Work and Income).
5. The Employer acknowledges that the Employee has specific learning objectives and agrees to assist in meeting these objectives.
6. If the Employer fails to take the agreed steps to meet the learning objectives of the Employee, Work and Income may refuse payment of the Subsidy payable in respect of that Employee under this Agreement. Work and Income will notify the Employer of this decision in writing.
7. Work and Income accepts no responsibility in relation to the employment of any employee by the Employer under this Agreement, including but not limited to any responsibility for the suitability for the work or as to the appropriate conditions of employment to be applied or otherwise.
8. The Employer will maintain safe working conditions (in accordance with any relevant legislation, including the requirements of WorkSafe New Zealand).
9. The Employer agrees to comply with the Privacy Act 1993 and to ensure that all its officials, employees and subcontractors do the same. This includes not using or disclosing any of the Employee's personal information except as permitted by law.
10. Work and Income will pay the stated Subsidy to the Employer in respect of the Employee employed by the Employer.
11. The Employer will give Work and Income staff access at all reasonable times to any premises where a project under this Agreement (Project) is being carried out, or where records relating to a Project are kept (e.g. wage and time records), to enable Work and Income staff to monitor the progress of the Project and also to carry out any other audit function.
12. The Employer agrees to make relevant wage records and time records available to Work and Income when requested to do so. If such a record is not provided, Work and Income may refuse to make payments on the claim and will notify the Employer of this decision in writing.
13. The Subsidy to be paid under this Agreement is for the sole purpose of subsidising the training and/or wages of the Employee, employed by the Employer, and the Employer undertakes not to use the Subsidy for any other purpose.
14. The Employer is responsible for paying GST, ACC levies, PAYE and Holiday pay, and any other employment related expenses in respect of the Employee e.g. purchasing accident insurance.
15. The Employer agrees to claim the subsidy for the Employee only for the days for which wages have been paid to the Employee. Work and Income will not pay the Employer a Subsidy in respect of any day for which wages have not been paid to the Employee concerned.



16. The Employer shall make all claims under this Agreement within the period of the Agreement or within 3 months after the Agreement period has ended, or within 3 months of the Employee ceasing to be employed, whichever is the earlier. Work and Income will not pay any claims submitted outside this period.
17. Work and Income will issue a tax invoice on the Employer's behalf in respect of the Employer's provision of paid work to the Employee. The Employer will not issue a tax invoice in respect of this provision of paid employment. Work and Income will send the Employer the tax invoice on payment of each claim and retain a copy.
18. Any money paid to the Employer by Work and Income, whether during the course of or after the work has been completed, where the Employer is not entitled to the money under this Agreement, for whatever reason, shall be a debt due to Work and Income. Work and Income may recover the money or set the debt off against any other money or property payable to the Employer by Work and Income whether under this Agreement or not.
19. The Employer agrees that any monies paid under this Agreement which are not used for the purpose specified by this Agreement shall be recoverable by Work and Income.
20. Either party may terminate this Agreement by providing two weeks written notice to the other party.
21. Work and Income may terminate or suspend this Agreement immediately if the Employer is in breach of any of the Conditions of this Agreement.
22. Work and Income may cancel this Agreement if the Employer is or becomes bankrupt or insolvent.
23. The Employer agrees to advise Work and Income immediately of any change in circumstances, including but not limited to:
  - a. the Employee ceasing work/training; or
  - b. the Employer ceasing operation of its business.
24. Any dispute arising during the course of this Agreement will be dealt with between the Employer and Work and Income's nominated representative. If the parties cannot resolve the dispute within 10 days of the matter being referred to them, the dispute may be submitted to mediation if the parties agree to do so. Otherwise, each party may take such rights as are available at law.
25. The parties may vary this Agreement. A variation must be agreed by both parties and recorded:
  - a. in writing and signed by both parties; or
  - b. through an exchange of emails where the authors have delegated authority to approve the variation.
