Re Official Information Act Request – Information on remuneration of Auckland DHB Employees

I refer to your Official Information Act request dated 11 April 2017 requesting the following information:

The ADHB annual report routinely provides information in regards to the remuneration of employees over \$100,000 per year.

Following this same method, can you please provide the same data for all employees of ADHB for the years 2014 and 2015?

To be clear, this means frequency of employees at varying \$10,000 pay brackets from \$0 to top remuneration rate for the year irrespective of FTE.

Can I also ask for ADHB to provide a separate set of figures in the same manner but for solely full FTE employees.

Response:

Each year, as required by the Crown Entities Act, Auckland DHB publishes numbers of its employees receiving total remuneration over \$100,000 per year, in \$10,000 band in its annual report.

As per your request, Table 1 below presents the breakdown for both 2014 and 2015 Fiscal Years regardless of FTE. Please note that this information is accessible to the public on the internet should you need further contextual information. Table 2 presents the same breakdown, however for employees working full-time (i.e., one FTE).

There are in total 1,360 and 1403 employees (regardless of FTE) receiving a total remuneration of \$100K and above. This represents approximately 14% of our entire workforce.
