## 1 Purpose

The purpose of the audit was to provide assurance that Nelson Marlborough Institute of Technology Te Whare Wānanga o Te Tau Ihu o Te Waka a Māui (NMIT) is meeting the Investment Plan Funding Conditions as referred to in the Tertiary Education Commission (TEC) letter of approval dated 21 December 2015. The funding approved includes Student Achievement Component (SAC), Youth Guarantee, ESOL – Intensive Literacy and Numeracy, ESOL – Refugee English Fund and Adult Community Education (ACE) funding.

## 2 Scope

The scope of the audit was aligned to the performance commitments in the TEC Investment Plan and the associated funding obligations between the TEC and NMIT. The scope was outlined in the audit arrangements letter.

The focus areas included:

- The reporting through the Single Data Return, including recording enrolments and withdrawals.
- Compliance with Student Achievement Component funding conditions.
- The Annual Maximum Fee Movement (AMFM) policy relating to fees and course costs.
- The refund of fees that have been overcharged.
- The financial support for the equipment infrastructure required to deliver the approved qualifications.
- Whether inducements or benefits have been provided to students.
- Responsibility for subcontracting arrangements.
- Compliance with Youth Guarantee funding conditions.
- Compliance with ESOL ILN funding conditions.
- Compliance with the requirements in Part 16 of the Education Act 1989.
- Any other matters relating to funding provided by the TEC.

An audit is a snapshot of an organisation's performance at a particular point in time and may not, as such, provide a view of ongoing compliance. An audit is based on sampling and issues may remain undetected. The outcome of this audit will contribute to decisions made by the TEC relating to current and future funding.

### 3 Background

This audit is part of the TEC's ongoing monitoring of Tertiary Education Organisations.

NMIT is an Institute of Technology based in Nelson offering qualifications from foundation to post-graduate programmes that are funded by the TEC.

In addition to the main campus in Nelson, the Institute has campuses in Blenheim, Woodbourne, Richmond and Auckland.

The following eleven qualifications were reviewed during the audit:

- NE4955 Certificate in Trades and Primary Industries (Level 2)
- OT4960 Certificate in Automotive Engineering (Level 3)
- NC1421 National Certificate in Motor Industry (Automotive Electrical and Mechanical Engineering) (Level 3)
- NC1621 National Certificate in Seafood Processing (Level 3)
- NE4553 Certificate in Vineyard Practice (Level 3)
- NE4340 Diploma in Viticulture and Wine Production (Level 5)
- HB3871 Diploma in Beauty Therapy (Level 5)
- NE4648 Diploma in Career Guidance (Level 6)
- 112950 New Zealand Diploma in Engineering (Level 6)
- NE4864 Bachelor in Viticulture and Wine Production (Level 7)
- NE4507 Bachelor of Information Technology (Level 7).

## 4 Key Findings

The key findings were:

- Learners enrolled in Intensive Literacy and Numeracy English for Speakers of Other Languages (ESOL – ILN) had not been systematically assessed against two funding conditions, ESOL004: TEO to ensure that learners are eligible and ESOL011: TEO only to enrol learner for no more than five years. Implementing a structured decision-making process prior to acceptance on the programme will ensure that all criteria has been considered and documented.
- Funding condition ESOL013: TEO to provide specified amount of provision to learners specifies that, on average, there is 200 hours of provision per learner.
   NMIT could not confirm during the audit that this was 200 hours of contact time and may have included some non-contact hours.
- NMIT has a subcontracting agreement with Skills Update Training Institute to deliver training in NE4648 Diploma in Career Guidance (Level 6). The agreement was originally negotiated in 2010 and needs to be reviewed.
- NMIT has a subcontracting agreement with Seafood Training Services Limited to deliver training in NC1621 National Certificate in Seafood Processing (Level 3). The contract for provision of services does not specify which party is responsible for reporting unit standard achievements to the New Zealand Qualifications Authority (NZQA).
- NC1421 National Certificate in Motor Industry (Automotive Electrical and Mechanical Engineering) (Level 3) is a 268 credit qualification. In the open cube for 2015 the course completion Educational Performance Indicator is 99.1%. NMIT commented that courses are reported through the student management system after the student has successfully completed the unit standard.

### 5 Recommendations

The main recommendations are:

- NMIT reviews the enrolment process for learners enrolled in ESOL ILN to ensure there is a structured decision-making process to support the acceptance decision.
- NMIT to review the process for recording contact hours for learners enrolled in ESOL – ILN.
- Subcontracting agreements need to be reviewed and updated to ensure they
  reflect the schedule of approved qualifications in the Mix of Provision and
  specify the party responsible for reporting unit standard achievements to NZQA.
- NMIT to discuss with the ITP Investment Team the TEC's expectations relating
  to the reporting of course completions for NC1421 National Certificate in Motor
  Industry (Automotive Electrical and Mechanical Engineering) (Level 3) and how
  each enrolment should be reported through the student management system.

### **Part Two**

## **Findings**

Detailed findings are summarised in each of the audit focus areas.

#### Overview

- A sample of 60 files was selected for audit. The sample covered enrolments reported in the December 2015 and August 2016 Single Data Return.
- Interviews were held at the NMIT campus in Blenheim and main campus in Nelson. The audit included a visit to the Richmond campus.
- Management interviewed included the Chief Executive, members of the management team and personnel from the eleven selected programmes.
- There were no concerns with data reported through the Single Data Return, although there is
  one matter to follow up with the TEC relating to NC1421 National Certificate in Motor Industry
  (Automotive Electrical and Mechanical Engineering) (Level 3).
