# 2) UPDATE on Tourism and Rangitikei.com (formerly Rangitikei Tourism).

Following the R.com (R.T) AGM meeting held at Awastone River Haven, Mangaweka on 15/11/2016 and the failure to create a full new committee, suggestions to fold the organisation and possibly bring it 'in-house' to RDC were discussed. A further suggestion to put out to the membership one final prompter to see if there was a willing committee out there was facilitated by stand in chairperson Tricia Eames, yet this also received a relatively small response in terms of numbers. Following this another meeting was set.

Follow-up Meeting Held: Monday, 13<sup>th</sup> February 2017 at 7.35 pm Awastone, Mangaweka.

10 People in Attendance (with 12 apologies).

Tricia provided the history of Rangitikei Tourism as an incorporated society, advising that the AGM had been poorly attended, and no Committee had been elected. Subsequently members were emailed asking for their comment on the future of Rangitikei Tourism (RT). This meeting had been called to make a decision as to where to go from here.

**Much discussion followed.** While some members expressed an interest in assisting with promotional events etc, there was no expression of interest in being the Chairperson and the problem of establishing a committed working committee continued to dominate. Mayor Andy advised that Rangitikei District Council was the principal funder of RT and that Council would be prepared to take over the website administration functions, at least ensuring information was accurate and current, and that web enquiries would be answered.

Though one attendee was keen to see the current organisation structure continue, yet **again** the problem of establishing a committed working committee continued to dominate, and the feeling was that some resolution had to be made at this meeting. Further discussion evolved around the Council taking over the administration of RT and what this might look like; It was agreed that if there were interested parties willing to become involved with promotion, events, etc, that an advisory group could be established to allow participation and representation from the various interest groups.

## Ultimately these resolutions were put to the meeting.

All were carried unanimously (excepting resolution 1, which had 1 against).

- 1: That Rangitikei Tourism Inc be wound up (Carried lagainst)
- 2: That authority be given to Rangitikei District Council to seek legal and financial advice on winding up Rangitikei Tourism Inc. (Carried).
- 3: That authority be given to Rangitikei District Council to take over the administrative functions of Rangitikei Tourism Inc., including the website function. (Carried).
- 4: That an advisory group be set up to liaise with Rangitikei District Council if the opportunity arises in the future. (Carried).

Expressions of gratitude were shared by the attendees for all Chairs, committee members, Administrators, and all other helpers who had served the organisation over the years.

The Meeting closed at 9.03 pm.
