Thank you for your email of 8 March 2017 requesting for the following information under the Official Information Act 1982 (the Act):

*Can you please provide the supporting documentation that MBIE used as the basis to issue Multiproof consent A10108 (circus marquee), in particular for fire safety.*

*This includes at least the following which I am aware exists:*

- *Fire report and supporting calculations*
- *Producer statement PS1 from designer*
- *Producer statement PS2 (peer review)*
- *Correspondence between the parties, in particular the MBIE and their internal or external experts that they used as part of the decision.*

The Ministry of Business, Innovation and Employment (MBIE) has interpreted your request to include the supporting documentation used when issuing the National Multiple-Use Approval for Flaming Phoenix Entertainment Limited, certificate number A10108.

In response to your request, 53 documents have been found within the scope of your request and are being released to you. They are summarised in the attached document schedule.

Please note that some information within the released documents has been redacted as it falls outside the scope of your request, and some information within the documents has been withheld under section 9(2)(a) of the Act, to protect the privacy of natural persons. Additionally, duplicate documents have only been provided once where identified.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the decision to withhold information under section 9 of the Act is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review of my decision by the Ombudsman, in accordance with section 28(3) of the Act. The relevant details are:
