Thank you for your application in relation to an exemption from Land Transport Rules.

After careful consideration the NZ Transport Agency has granted your vehicles and their drivers an exemption from Land Transport Rules.

To summarise, the vehicles are exempt from specified class NA vehicle requirements (so that they may be entry certified, registered and operated on a road). Furthermore, provided that NZ Post Ltd obtains separate approval from individual Road Controlling Authorities (RCA's), the vehicles may be driven along a footpath subject to any conditions imposed by these exemptions and by the RCA's.

A copy of the attached exemption must be carried in the vehicles at all times and must be presented on request from an enforcement officer.

# SCHEDULE 2: Exempted Requirements

Land Transport Rule: Interior Impact 2001

- 2.3(1) Interior fittings, controls, and surfaces must comply, if specified in Table 2.1, with a version, as specified in 2.3(4), of:
- (a) the two approved vehicle standards in 2.3(2)(a); or
- (b) the approved vehicle standard in 2.3(2)(b); or
- (c) the approved vehicle standard in 2.3(2)(c); or
- (d) the three approved vehicle standards in 2.3(2)(d);

or

(e) the four approved vehicle standards in 2.3(2)(e).

Land Transport Rule: Seatbelts and Seatbelt Anchorages 2002

All requirements of the Rule

Land Transport Rule: Seats and Seat Anchorages 2002, Section 2.1

- 2.1(1) Seats and seat anchorages in a motor vehicle must comply, as specified in *Table 2.1*:
- (a) with 2.2; and
- (b) for vehicles of Classes MA, MB, MC and NA, manufactured on or after 1 October 2002, with an approved vehicle standard in 2.3.

Land Transport Rule: Light Vehicle Brakes 2002, Section 2.5

2.5(1) A brake must comply, if specified in *Table 2.3*, with a version, as specified in *2.5(3)*, of an approved vehicle standard for brakes in *2.5(2)*.

Land Transport Rule: External Projections 2001, section 2.1

## 2.1 Requirements for motor vehicles with external projections

A motor vehicle with external projections must comply with the relevant requirements in *Table 2.1* or *Table 2.2*.

Land Transport (Road User) Rule 2004

2.13(1) A driver must not drive a motor vehicle along a footpath.

## SCHEDULE 3: Conditions of this exemption:

- a) The vehicles cannot be operated on a footpath unless specific written approval has been sought from and granted to NZ Post by the relevant Road Controlling Authority (RCA); and
- b) Operation of the vehicles on a footpath must comply with all conditions specified in this exemption and by the relevant RCA; and
- c) On a footpath the vehicles must be operated at a safe speed for the conditions and must not exceed a speed of 20 km/h; and
- d) The operator of the vehicle must give way to all other footpath users; and
- e) The operator of the vehicle must wear an approved Motorcycle Helmet when operating the vehicle;
- f) The vehicle must be operated in accordance with the NZ Post "Safety Management Plan for 4 Wheel Vehicles on Footpath," and any other relevant requirements or procedures specified by NZ Post; and
- g) The operator of the vehicle must have undergone appropriate training in the use of the vehicle, as specified by NZ Post and NZ Post must retain records of the training; and
- h) This exemption is valid only while the vehicle is owned by New Zealand Post Limited; and
- i) A copy of this exemption must be carried in the vehicles at all times and must be presented on request from an enforcement officer; and
- j) A copy of this exemption must be retained by the Vehicle Inspection organisation on the vehicle file; and
- k) This exemption may be revoked at any time by the New Zealand Transport Agency.
