Thank you for your email of 2 April 2017, in which you requested, pursuant to the Official Information Act 1982 (the Act):

Copies of any correspondence sent to or received from or otherwise held in any form between the New Zealand Ministry of Defence and Rodney Hide.

On 1 May, I extended the timeframe for providing a response to your request to 19 May, in order to complete necessary consultations.

There are challenges responding to your request given the lack of a time period and given you have not provided a specific topic that you are interested in. Given Mr Hide served as a Member of Parliament from 1996, there is a long period in which he may have raised matters with the Ministry of Defence as a representative (in addition to any potential requests made in a personal capacity).

The age of some of the material makes it difficult to search, as it predates the regularised use of an electronic document and records management system, which would be easier to search.

A search of the Ministry's electronic filing system has identified responses to eight Official Information Act requests that fall within the scope of your request. Copies of the response letters to Mr Hide are provided, which generally summarise his original request. Also included are acknowledgement letters and, in one instance, a scanned copy of the original request. Please note the letter dated 19 December 2001 includes a typo whereby the numbers listing the documents released start from 15, instead of 1. Staff have checked and do not believe there was any other material released to Mr Hide in response to this particular request.

I have not included the associated attachments because of the difficulty accessing these. given the age. Doing so will necessitate manually searching a number of historic volumes. If you are interested in attachments to specific letters, please advise me of the relevant details and Ministry staff will be able to use this refinement to search for the material.

Please note that the electronic files that have been searched are limited to material from 2001 onward. As your request currently stands, searching all potential pre-2001 volumes for any potential correspondence to or from Mr Hide would involve substantial collation and research. It would therefore be declined under section 18(f) of the Official Information. If you would like to refine your request to a particular type of correspondence – such as Official Information Act requests – and to a specific time period, I would be happy to reconsider this.

Under section 28(3) of the Act you have the right to request the Ombudsman to investigate and review this response.
