## Request made under the Official Information Act 1982

Thank you for your email of 9 May 2017 requesting the following information under the Official Information Act 1982 (the OIA):

In relation to the Local Government Commission announcements during 2016 about its Strengthening the Wellington Region reorganisation process. I am interested in understanding the consultations and progress being made by the review.

- 1. Can I please have a copy of all meetings and/or presentations held in 2016 or 2017 with the Local Government Commission where the Transport Identified Priority Area was discussed? This includes any meeting agenda's, minutes, and any supporting reports/presentations.
- 2. Can I please have a copy of all reports received from the Local Government Commission in 2016 or 2017 where the Transport Identified Priority Area was discussed?
- 3. Can I please have a copy of all reports received provided to the Local Government Commission in 2016 or 2017 where the Transport Identified Priority Area was discussed?
- 4. Can I please have a copy of all correspondence with the Local Government Commission since January 2016 where the Transport Identified Priority Area was discussed?

Please find attached as Appendix 1 a list of all documents falling within the scope of your request and any OIA provisions applied. Some information in the attachments has been withheld under section 9(2)(a) of the Act to protect the privacy of natural persons, and section 18(d) as the information requested is publicly available. We have provided links to this information.

With respect to the decision to withhold names, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.
