

**Reporter Comments** 

Called to scene of multiple scrub fires on the 3 May and 7 May. Over the preceding week there had been multiple scrub fires lit at night along with the Piha chip shop on the 7 May.

The multiple fires looked at on the 3 May had been light from the Marahwara walkway North Piha to the intersection of Sylvan Glade and around 35 Beach Valley Road South Piha.

The largest fires were the ones on the walkway and on Lion Rock the rest of the fires were small due to the low temperature and dew on the grasses being lit. The fires in the vicinity of Beach Valley Road were the only fires lit close to a house at the address and the toilet block.

No ignition source was found at any of the points or areas of origin.

After the fires on the morning of the 7 May a specialist rural fire investigator was requested. The report supplied by the investigator is available on 'N' drive under the fire numbers for these multiple fires. The report covers all the suspicious fires over the week. Photos are also available on 'N' drive.
