Dear Ms Fairey

Thank you for your email of 3 April 2013 requesting, under the Official Information Act 1982, meeting notes and action points with Auckland Sexual Abuse HELP (ASAH) for the specified dates and copies of emails to and from ASAH since 30 October 2012.

Please find enclosed copies of the meeting notes for: 18 January 2012; 23 February 2012; and 15 March 2012.

The above dated minutes were distributed to officials representing the Ministry of Justice, the Ministry of Health, New Zealand Police and the Accident Compensation Corporation who also may have made notes for themselves on work that they needed to follow up on.

The Ministry of Social Development does not hold any formal meeting notes or action points for the remainder of 2012. As discussions about ASAH since that time were of an informal nature and meeting notes and action points were not circulated. Therefore I am refusing your request for meeting notes and action points for the remaining specified dates under section 18(e) of the Official Information Act request as this information does not exist in this format.

Since the end of 2012 Family and Community Services, a service of the Ministry of Social Development, has worked with ASAH to consider sustainable funding options. I have enclosed copies of emails between ASAH and the Ministry.

You will note that some information has been withheld from the minutes and the emails under section 9(2)(a) of the Official Information Act to protect people's privacy. I do not consider the public interest in the names and contact details of these individuals is outweighed by the right to privacy for those individuals.

Information about funding and the outcomes chart has been withheld under section 9(2)(f)(iv) of the Act as this is under active consideration. The release of this information prior to agreement being reached would likely prejudice the quality and impartiality of information and advice generated, and the wider public interest of effective government would not be served.









Part of the email titled Draft Scope dated 1 February 2013 and the project scope document have been withheld under section 9(2)(g)(i) of the Act to protect the effective conduct of public affairs through the free and frank expression of opinions. I believe the greater public interest is in the ability of individuals to express opinions in the course of their duty.

I hope you find these documents about ASAH helpful. You have the right to seek an investigation and review of my response by the Ombudsman, whose address for contact purposes is:

Action points from meeting Thursday 23 February 2012

Meeting with ASAH

In relation to the questions seeking further information from ASAH, ASAH noted that some of the information asked for has already been provided. Agencies agreed to circulate to each other any reports or information that they had relating to ASAH that souls help answer these auestions.

Agreed that the first two questions, relating to the breakdown of ASAH's costs, should be prioritised. ASAH noted that it would take up to the end of March to answer these two questions.

Agreed to add another question on volumes of calls across different times of day. ASAH to gather data on this.

It was noted that ASAH would need to consider whether there are cost savings that can be made, and that any proposal will need to demonstrate that all options have been considered, including national approaches (eg national phoneline).

Agreed that a three month interim funding package is needed, as it is unlikely a sustainable arrangement can be implemented by the time current funding expires at the end of May, partly due to the timeframes required for ASAH to compile their key financial information.

Agreed that regular meetings are required to progress this work.

Agreed that the next meeting will be held in two weeks time, and MSD will be in touch with attendees to organise this,

The focus of the next meeting will be on an interim package to take ASAH through to August 2012

ASAH to advise 9(2)(a) of the amount of funding needed for a three month interim funding package by Friday (today) - completed.

ASAH advises that:

The amount per month- based on the interim funding we have been working with over the last two years is:

\$30,087 per month."

Officials reiterated their personal commitment to seeing this work through.


