## Response to your request for official information

Thank you for your email of 20 May 2017 requesting information from the Ministry of Business, Innovation & Employment under the Official Information Act 1982. Part 3 and 4 of your request have been transferred to the Ministry of Health.

- 3. For each of the years 2009-2017, the money value of restraint and forfeiture orders that were re-distributed through the "hypothecated fund" to institutions that target the drivers of drug and organised crime.
- 4. For each of the years 2009-2017, specifically which government agencies / institutions that target the drivers of drug and organised crime were successful in their application for this "hypothecated fund" and approved by Cabinet.

Money value of restraint and forfeiture orders that were paid into the Proceeds of Crime Fund since the passing of the Criminal Proceeds (Recovery) Act 2009

The annual funds paid into the Proceeds of Crime Fund since the passing of the Criminal Proceeds (Recovery) Act 2009 were \$4.105m in 2012/13, \$6.937m in 2013/14, \$5.866m in 2015/16 and \$14.087m in 2016/17, totalling \$30.995m.

Successful applications made by Government agencies to the Proceeds of Crime Fund
