## LOCAL GOVERNMENT OFFICIAL INFORMATION AND MEETINGS ACT (1987) – REQUEST FOR INFORMATION – COUNCIL CONTROLLED ORGANISATIONS OF CHRISTCHURCH

I refer to your email dated 23 October 2012 requesting information in relation to Christchurch City Council Controlled Organisations.

Please note that your request for information is being handled under the provisions of the Local Government Official Information and Meetings Act 1987 (the "Act").

I refer to your request below and respond accordingly:

a) A list of all CCOs that Christchurch City Council has ownership interests in, including any CCOs which CCC owns less than 50% of, but combined with other local authorities they are a CCO due to ownership adding up to more than 50%. I would like this to include organizations that are CCOs both due to the definition in s6(1)(a) and s6(1)(b).
