All access routes shall have a floor slip resistance to comply with the NZ Building Code Di Access Routes

Except for H5 timber member as specified on plan, all other timber members exposed to the weather are to be H3.2 treated minimum to comply with NZS 3602:2003.

Construction works shall be performed in a manner that avoids the likelihood of causing danger or hazards to people or property on or off site. The unauthorised entry of children on site is to be prevented. Site safety is to comply with F5 of the NZBC.

All metal fixings designed to comply with NZS 3604 shall comply with Section 4 Table 4.1 for protection against corrosion. Please note metal fasteners, including bolts within 600mm of the ground or exposed to the weather are to be stainless steel and or galvanised plus epoxy-coated.

This consent is approved with the understanding that falling from one side of the bridge in o more than 1m fall (i.e. barrier is provided to the other side of the bridge where people could fall from more than 1m).
