Questions 5,6,7 BoT Response

These questions ask for information that all relates to the employment contracts of individual board staff members. It therefore has no reason upon which it could decide that other considerations (that might make it desirable in the public interest to provide the information) outweigh the board's responsibility to protect the privacy of information it holds about its staff. The information is therefore withheld to protect the privacy of natural persons (refer section 9 of the Official Information Act 1982).
