Thank you for your request made under the Local Government Official Information and Meetings Act 1987 (the Act), received on 25 September 2017. You requested the following information:

*all information about the ownership of bridges crossing Karori Stream to residential properties in South Karori Road, including any emails, engineers reports and memos since January 2015.*

While the number of documents relating to the ownership of the bridges is very limited, I have included a number of other documents that may be of interest to you.
