Could I please request the test certificates for the 2017 Diwali Festival fireworks displays - Waitakere, Manukau & Auckland CBD.

- *The Waitakere display was on 1 October at Trusts Arena, 65-67 Central Park Dr, Henderson, Auckland 0610*
- *The Manukau display was on 8 October at the Manukau Sports Bowl, Clover Park, Auckland 2023*
- *The Auckland CBD display will be on 15 October in the Auckland CBD (visible from Aotea Square but currently unsure of exact address)*

- 5) All fall-out shall be consumed in flight.
- 6) Access to and from the Greys Avenue carpark shall for the duration of the display, whether by pedestrians or vehicles, be limited to the approved handler-in-charge and their assistants only.
