Thank you for your email dated 17 November 2012, requesting Station Boarding Data for 2011 and 2012.

Auckland Transport conducts periodic "snap-shot" surveys primarily for internal use to monitor train loadings, long-term patronage trend analysis and contract management purposes. As a "snap-shot" there may be significant margin for error when comparing one year to another. The data is not adjusted for variances in the observed station usage as a result of service disruptions that may have occurred on the day of the survey.

In both 2011 and 2012 there were service disruptions on the day the counts were taken that would have affected normal patronage demand on parts of the network.

Moving forward, new data information will start to become available through the integrated ticketing system (AT HOP) shortly.

Attached are the boarding counts from the last two years' surveys together with the counts for 2010 as comparison. This data should not be reproduced or otherwise used in any way without acknowledgement of its source and inclusion of the disclaimer appearing at the top of that page.

Should you believe that we have not responded appropriately to your request, you have the right in accordance with section 27(3) of the LGOIMA to make a complaint to the Office of the Ombudsman to seek an investigation and review of the decision.
