
#### 1. Introduction

1.1. OnzO NZ, a dockless bike share scheme has launched approximately 100 yellow bikes around the Auckland city centre over the weekend. The below image shows some of the bicycles that are located on Quay St.



1.2 The bikes are accessed using an app and all have helmets attached to them. The image below indicates where the bicycles have been placed around the City.





#### 2. Background

- 2.1. There are several hundred dockless bikeshare systems operating across the world. The largest company Ofo operates 10 million bicycles globally.
- 2.2. The first dockless system started in 2014 and councils around the world have grappled with how to manage bicycles that aren't parked in a specific location and which in some cases have resulted in obstructions to pedestrians.
- 2.3. Users are charged a nominal fee for using the bicycles, sometimes with financial rewards for returning bikes to allocated areas or looking after bikes. The public access the bicycles through an app, which allows them to locate and pay for the bicycles.

#### 3. Status and Next Steps

- 3.1. This month, NZTA drafted a Code of Practice based on best practice from overseas cities, with the intention that it be adopted and modified by councils nationally to ensure that any bike share schemes that come to New Zealand, have bikes that remain maintained and do not obstruct the public realm.
- 3.2. We are in the process now of working with Auckland Council's Compliance team and Auckland Transport's legal team to ensure the Code of Practice aligns with Auckland Council's bylaws.

- 3.5. OnzO, the company who launched over the weekend had not approached Auckland Transport prior to launching but have however contacted me this morning to arrange a meeting to 'work together', this meeting has been set up for Friday.
- 3.6. We will provide a further update once the Code of Practise is complete. This does not affect Auckland Transport's work towards providing its own cycle share scheme, and we will continue to work with providers to find the best way forward for Auckland.
