# Request made under the Official Information Act 1982

Thank you for your email of 8 December 2017 requesting the following information under the Official Information Act 1982 (the Act):

I see no details about the Onehunga Port.

Can you provide specific information regarding NZTA's purchase or proposed purchase of the Onehunga Port.

Also missing was transaction date information. Dates of sale/transfers. Expiry dates for the "Heads of Agreement" and "Advance Agreement".

Please note, I would expect that "details" would also mean copies of any of these agreements are included.

On 9 January 2018, the NZ Transport Agency sent you an email clarifying how we were interpreting this request. We took your response of 12 January 2018 as confirming this clarification. On 19 January 2018, we notified you that we were extending the 20 working days available to respond to your request and that you would therefore receive a response on or before 20 February 2018.

Pursuant to our 12 January 2018 clarification with you, the information requested is defined as:

I have responded to the parts of your request in turn below.

## 1. Onehunga Port

An agreement in principle, which included an agreed purchase price, was reached with the owner of the Onehunga Port during August 2017. The draft Agreement including those terms was never signed by either party and was not finalised as the Transport Agency never completed the internal approval process to execute and enter into the Agreement. The landowner was advised on 25 October 2017 that approval for the purchase was not proceeding.

The actual Agreement, including the purchase price and further terms, is withheld under section 9(2)(b)(ii) of the Act, to protect the commercial position of the landowner. This section of the Act allows for the withholding of information where the making available of that information would be likely to unreasonably prejudice the commercial position of the person who supplied or who is the subject of the information. With respect to the information that has been withheld, I do not consider there are any factors which would render it desirable, in the public interest, to make the information available.

#### 2. All properties listed in the response to OIA-3363

A schedule of documents that fall within the scope of your request for copies of the Agreements is attached. Those Agreements contain all of the further details requested by you, where those are available.

Certain information (including names, signatures, addresses, occupations, email addresses and phone numbers) has been withheld under section 9(2)(a) of the Act. This section allows for the withholding of information to protect the privacy of natural persons.

With respect to the information that has been withheld, I do not consider there are any other factors which would render it desirable, in the public interest, to make the information available.

To the extent that some documents do not contain an expiry date, that portion of your request is refused under section 18(e) of the Act, as the information requested does not exist.

#### 3. 1-7 Sylvia Park Road and 19-21 Sylvia Park Road

We have already provided you with a brief overview of the option agreement on this property. We refuse your request for further information under section 9(2)(b)(ii) of the Act, to protect the commercial position of the landowner. This section of the Act allows for the withholding of information where the making available of that information would be likely to unreasonably prejudice the commercial position of the person who supplied or who is the subject of the information. With respect to the information that has been withheld, I do not consider there are any factors which would render it desirable, in the public interest, to make the information available.

# 4. 72 Frank Grey Place

We have already provided you with a brief overview of the option agreement on this property. We refuse your request for further information under section 9(2)(b)(ii) of the Act, to protect the commercial position of the landowner. This section of the Act allows for the withholding of information where the making available of that information would be likely to unreasonably prejudice the commercial position of the person who supplied or who is the subject of the information. With respect to the information that has been withheld, I do not consider there are any factors which would render it desirable, in the public interest, to make the information available.

### Your email of 22 January 2018

Thank you for your further clarification email of 22 January 2018. We understand from this email that your focus is to form a view of the current status of the Onehunga Port. As the information provided above includes an explanation of the current status of the Onehunga Port, we are not at this time treating your email of 22 January 2018 as a separate and active request.
